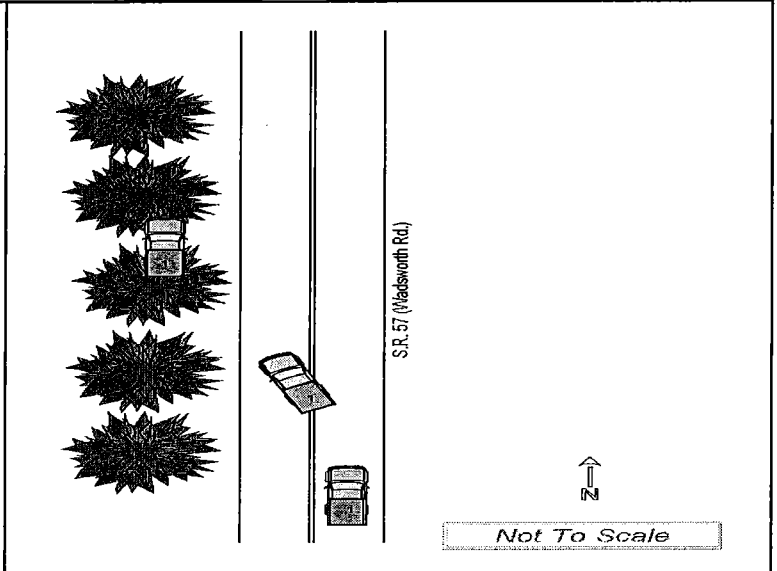

NARRATIVE

Unit #1 was traveling north on S.R. 57 (Wadsworth Road) when the vehicle veered off the roadway to the left, crossing the southbound lane. After the vehicle went off the west side of the roadway, it struck a pine tree head-on. On my arrival, the driver was not with the vehicle and was nowhere to be found. A drone team was used to check the area to make sure he didn't faint after leaving the scene of the accident. After about an hour and a half, the driver's father received a phone call stating the driver (his son) was okay and that he would deal with things the next day. Although the driver was not present, alcohol is believed to be a factor in the crash. The vehicle was towed by Lloyd's Towing, and the driver was cited at a later date for failing to maintain reasonable control, and leaving the scene of an accident.
