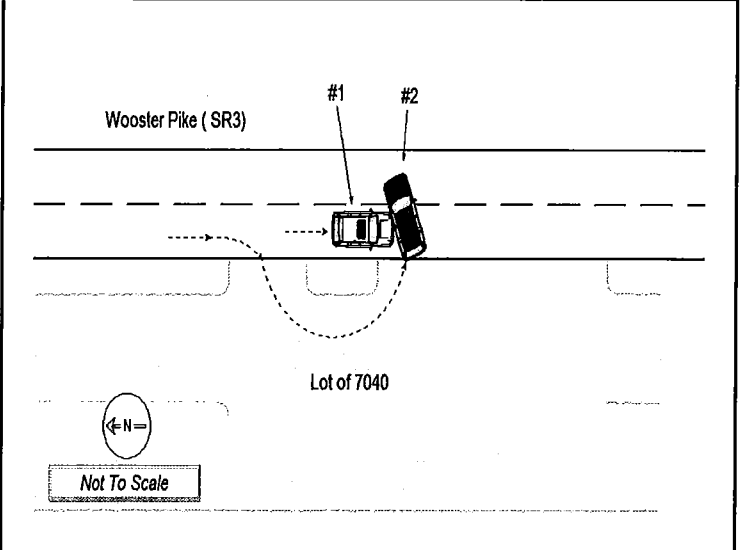

NARRATIVE

Unit #2, which was southbound on Wooster Pike, pulled into the gravel lot of 7040 Wooster Pike (Roto Rooter overflow lot) with the intention of turning around to go north. The driver of Unit #2 failed to yield the right of way to Unit #1, which was also southbound on Wooster Pike. Unit #1 struck Unit #2 in the driver's door, causing airbag deployment in both vehicles. The driver of Unit #1 complained of a possible broken right wrist, ankle pain and chest pain (external from the impact and not cardiac related). The passenger complained of right knee pain. Both were transported to Medina Hospital by Medina LST. The driver of Unit #2 claimed no injury at the scene, and refused treatment or transport by responding medics. Both vehicles sustained disabling damage and Unit #1 was towed by Jon's Towing. Unit #2 was towed by Heidi's Towing. The driver of Unit #2 was cited for failure to yield the right of way from a private drive.
