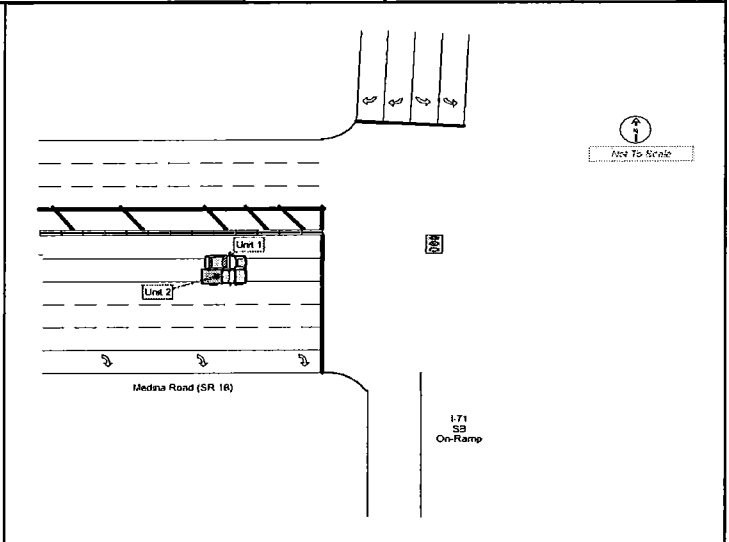

NARRATIVE
Unit 1 and 2 were both eastbound on Medina Rd. (SR-18) approaching Interstate 71. Both vehicles were in traffic lanes to eventually turn left (north) on I-71. The driver of Unit 1 advised his lane was backed up so he wanted to change lanes to the next lane to the right. The driver of Unit 2 stated he was already occupying that lane and attempted to evade Unit 1 until the collision happened. Unit 1 suffered damage to the passenger side front fender and Unit 2 sustained damage to the driver's side door and mirror. Both vehicles were driven from the scene.
