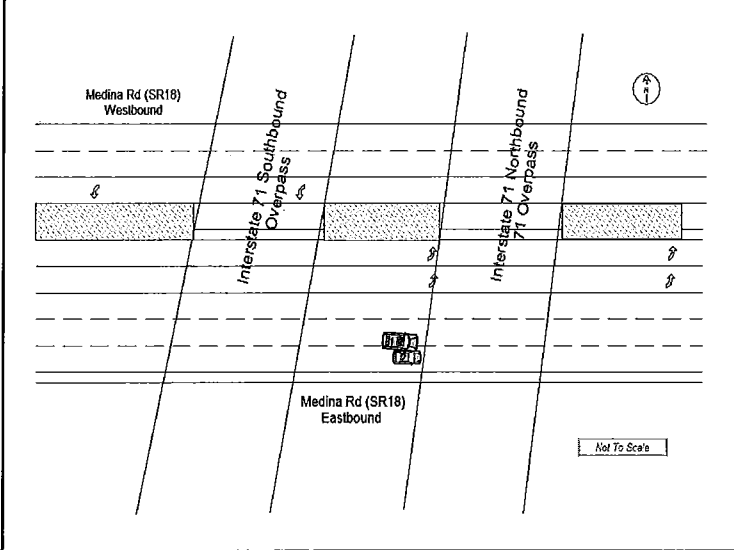

NARRATIVE
Unit 1 was traveling east on Medina Rd near the Interstate 71 overpass, and attempted to change lanes into the far south lane. Unit 2 was also traveling east on Medina Rd in the far south lane. Unit 1 began to merge into the far south lane striking unit 2. Unit 1 sustained damage to the front passenger side fender. Unit 2 sustained functional damage to the front bumper, lower cowl, and driver-side front fender. The driver of unit 1 was issued a citation for marked lanes. No injuries were reported, and both vehicles were driven from the scene.
