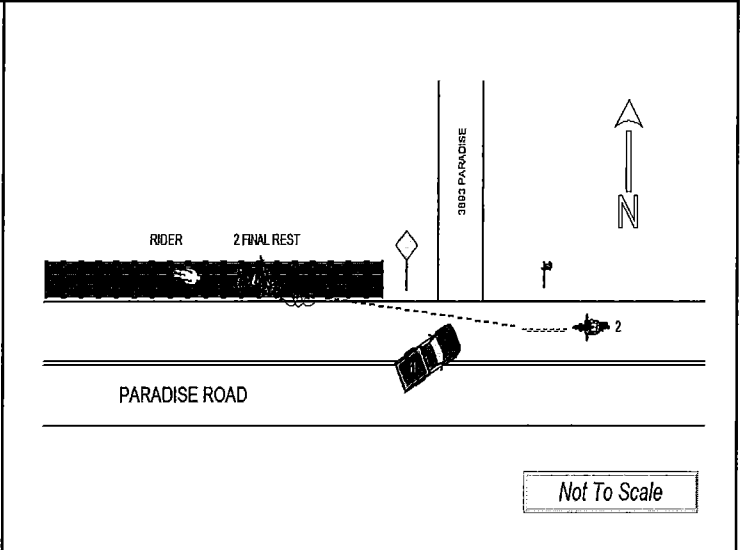

NARRATIVE
Unit #1 was turning left into the driveway at 3893 Paradise Road, Unit #1 did not see Unit #2 (a motorcycle) approaching from the east. Unit #2 swerved to avoid hitting Unit #1, exiting the roadway to the north and striking the ditch causing the rider to eject off the motorcycle and land in the ditch face down. The rider was transported by LST to Akron General for serious injuries. Unit #2 was towed by Trans County Towing, and the driver of Unit #1 was cited for failing to yield when turning left.
