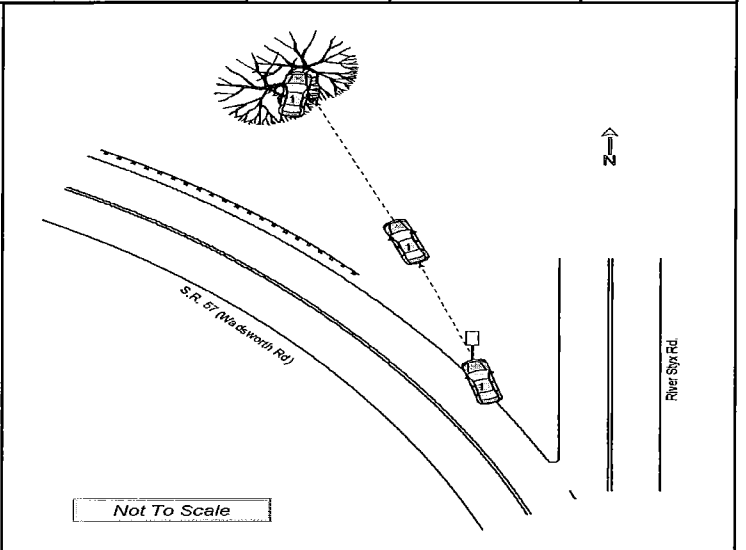

**NARRATIVE**

Unit #1 was traveling northbound on Wadsworth Road when the driver looked at her phone for GPS directions. The driver did not follow the curvature of the roadway and went off the roadway on the right shoulder. Unit #1 was unable to be corrected and traveled approximately 100ft before hitting a large tree head on. There was airbag deployment, however, no injuries were reported. The vehicle sustained disabling damage and had to be towed from the scene. The driver was cited for failing to maintain reasonable control.

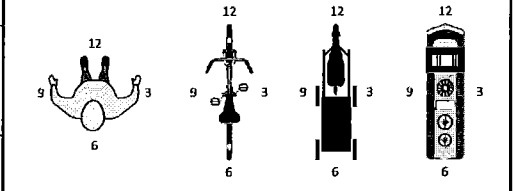
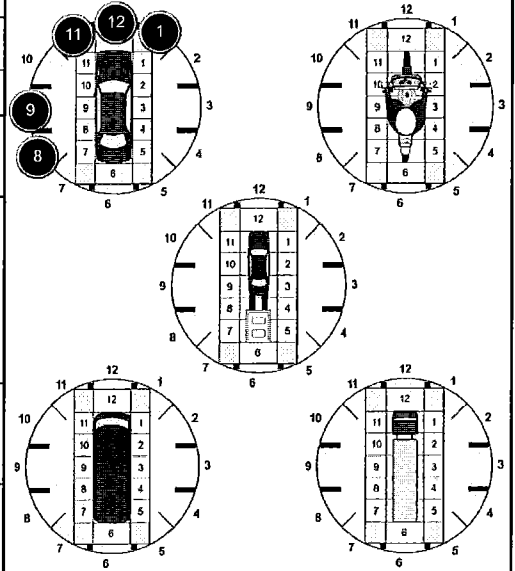
