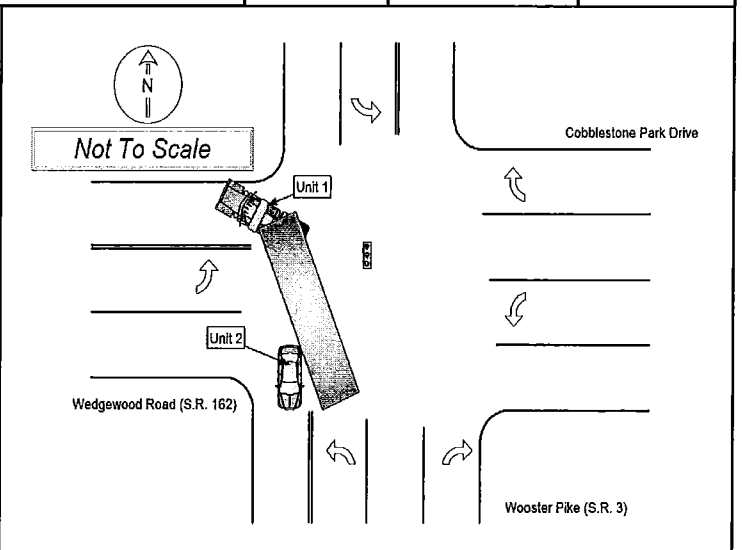

NARRATIVE
Unit 1 was facing north on Wooster Pike (SR 3) attempting to make a left on Wedgewood Road (SR 162.) Unit 2 just made a left on Wooster Pike and from Cobblestone Park and was stopped in traffic due to the road construction ahead. Unit 1's trailer came into contact with the rear of Unit 2 as Unit 1 turned. Unit 2 pulled into a nearby driveway and Unit 1 parked on Wedgewood Road. No injuries were reported, and the driver of Unit 1 was cited for rules for turns at intersections, for failing to maintain his position on the right side of the roadway.
