

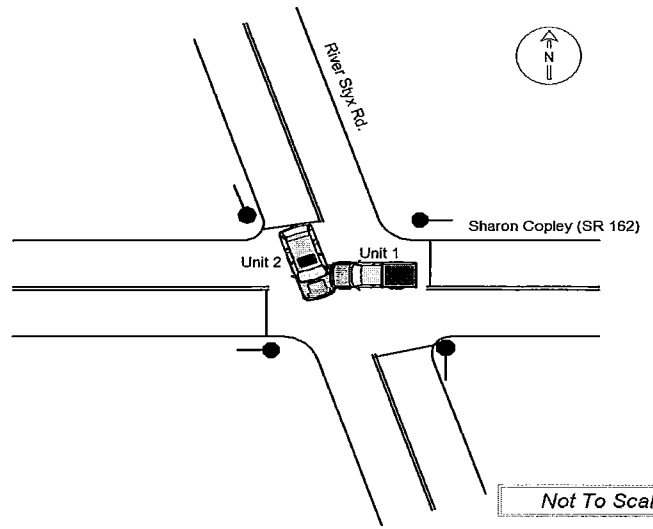

Unit 2 was south on River Styx Rd. and was stopped at the intersection with Sharon Copley Rd, behind another vehicle. The driver of Unit 2 said that he looked to his left at this point and did not see anyone. Unit 2 said that after the vehicle in front of him went, he went without looking to his left again. It was at this point that Unit 1 started to enter the intersection due to it being his turn. Unit 1 struck the front right of Unit 2. Unit 2 did not want to fill out an OH-3, but when asked, stated that he thought it was Unit 1's turn to go, but it could have been his, he didn't know because he was listening to music. There were no injuries and Unit 2 was towed by Bear's Towing. The driver of Unit 2 was cited for right of way at an intersection.
