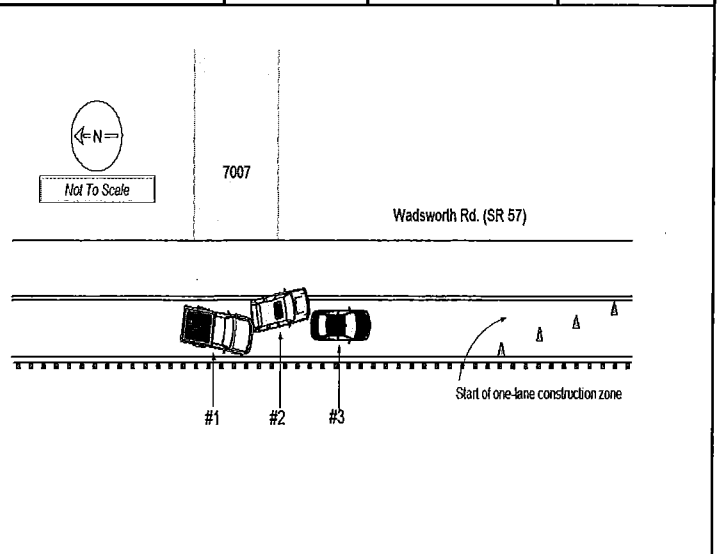

NARRATIVE  
Units #1, 2 and 3 were all southbound on Wadsworth Road (S.R. 57), and Units 2 and 3 were stopped in a construction zone and were waiting for traffic to move forward. Unit #1 came up behind Unit #2, which was still stationary, and struck it in the rear. Unit #2 was pushed forward into the rear of Unit #3, striking it in the left rear bumper. Unit #1 sustained disabling damage to the front and required recovery by Lloyd's Towing. Unit #2 also sustained disabling damage, and TransCounty Towing recovered it. Medina LST responded to the scene and evaluated the driver of Unit #1 and the juvenile passenger of Unit #2, though neither party was transported. The driver of Unit #1 was cited for ACDA.
