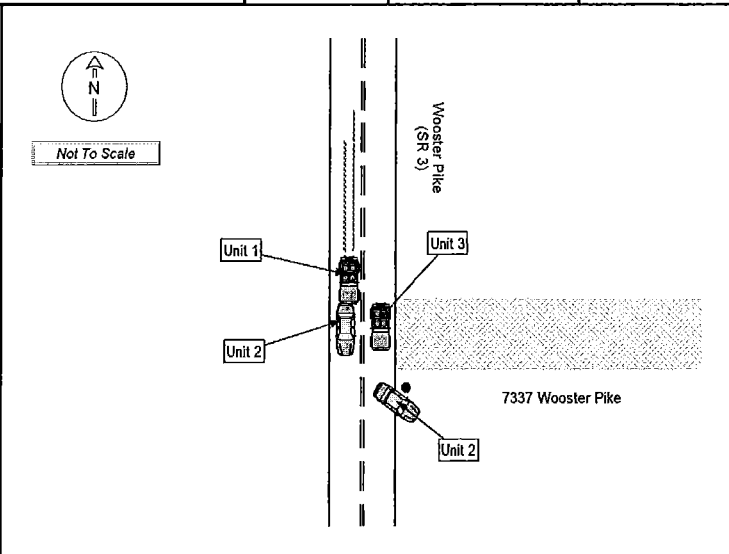

NARRATIVE
Unit 2 was stopped or slowed in traffic attempting to make a left turn in to 7337 Wooster Pike. Unit 3 was behind Unit 2 and Unit 1 was behind Unit 3. Unit 3 attempted to miss Unit 2 by entering the northbound lane next to Unit 2 after advising Unit 2 stopped suddenly. Unit 1 then attempted to brake but couldn't in time and struck the rear of Unit 2 pushing it on to the east side of the road. The occupants of Unit 2 complained of discomfort but refused treatment by LST. All other parties advised of no injuries. Unit 2 was towed from the scene by Lloyd's Towing. Unit 1 and 3 were driven from the scene, and the driver of Unit 1 was cited for ACDA.

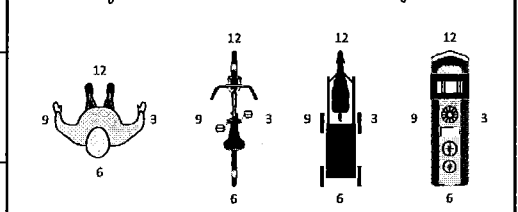
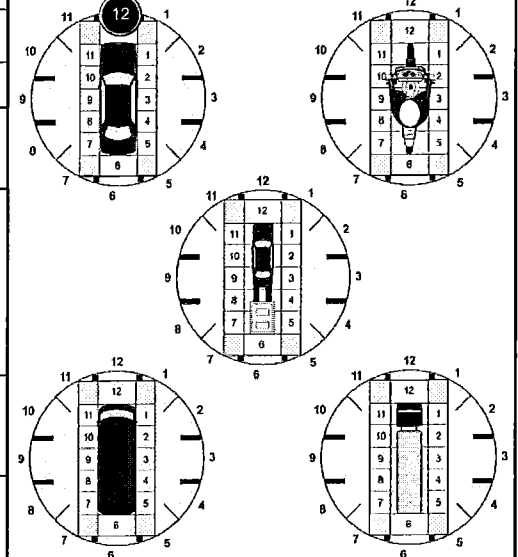
