

NARRATIVE
Unit 1 was eastbound on Ridgewood Road, when a rodent entered the roadway in the 3000 block. The driver of Unit 1 swerved to the right to avoid rodent, and ended up in the ditch on the south side of the roadway. There was no visible damage to the vehicle, though it is possible the underside was damaged as it scraped along the shoulder. The driver/owner requested a crash report, and the vehicle required a winch out by Lloyd's Towing. The driver reported no injuries, and was cited for failing to maintain reasonable control.
