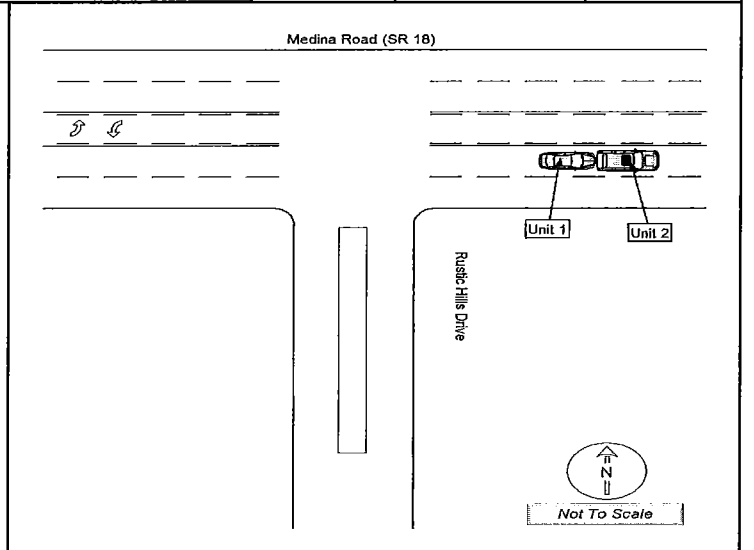

NARRATIVE  
Unit 2 was slowing down in traffic on Medina Road near Rustic Hills Drive. It should be noted Unit 1 and 2 were moved to a safer location prior to my arrival so the approximate location of the crash was agreed on by both parties. Unit 1 advised they attempted to stop in time but could not and struck the rear end of Unit 2. The driver of Unit 2 complained of knee pain but did not request an ambulance and instead drove herself to Medina Hospital. The driver of Unit 1 advised she was "shook up" and also denied an ambulance. Jon's Towing towed Unit 1 from the scene.

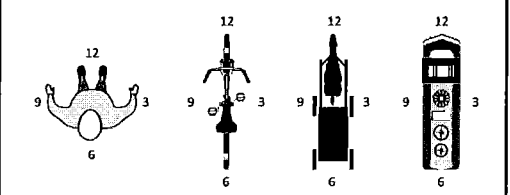
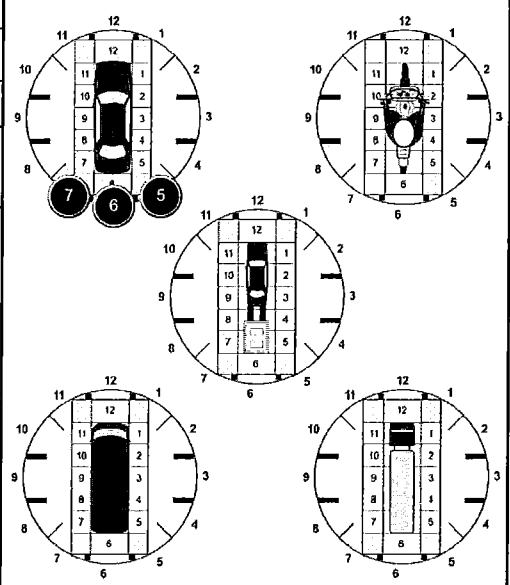
