NARRATIVE Unit 1 was stopped on Poe Road and attempted to make a left turn onto River Styx Road. A cement truck pulled along the right side of Unit 1 and was blocking the view of northbound traffic. Unit 1 turned left onto River Styx Road into the path of Unit 2, that was traveling north on River Styx Rd. Unit 1's front passenger-side bumper/fender struck Unit 2's front driver-side fender/bumper. Unit 2 went off the right side of the roadway striking a 45 MPH speed limit sign with the front passenger-side bumper. Unit 1 sustained functional damage to the passenger-side front fender. Unit 2 sustained disabling damage to the front of the vehicle and both side airbags were deployed. No injuries were reported. The driver of Unit 1 was issued a citation for right of way turning left. Unit 2 was towed from the scene by World Truck.

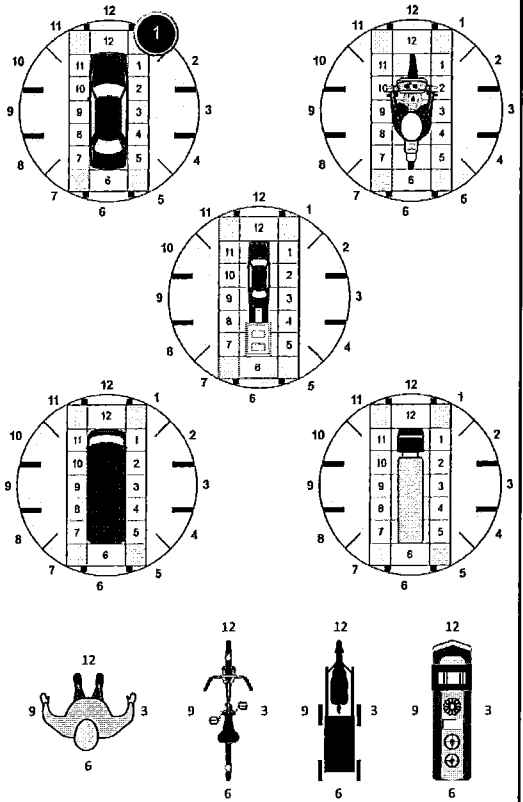

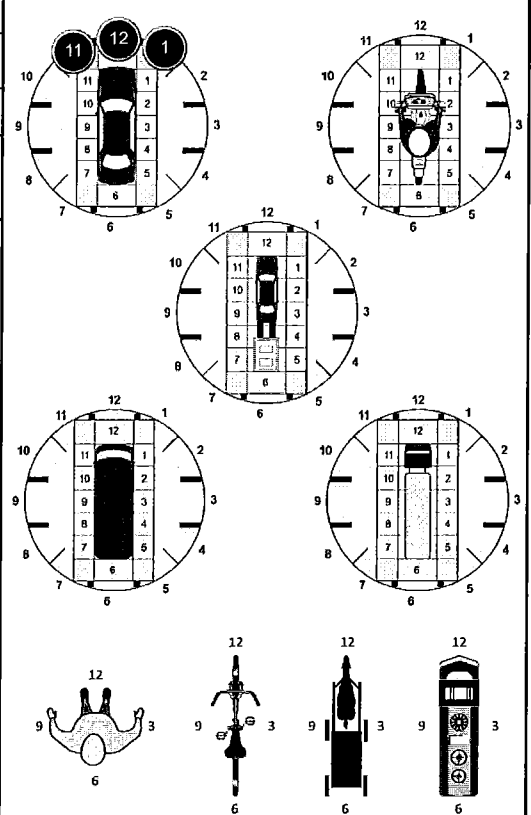
