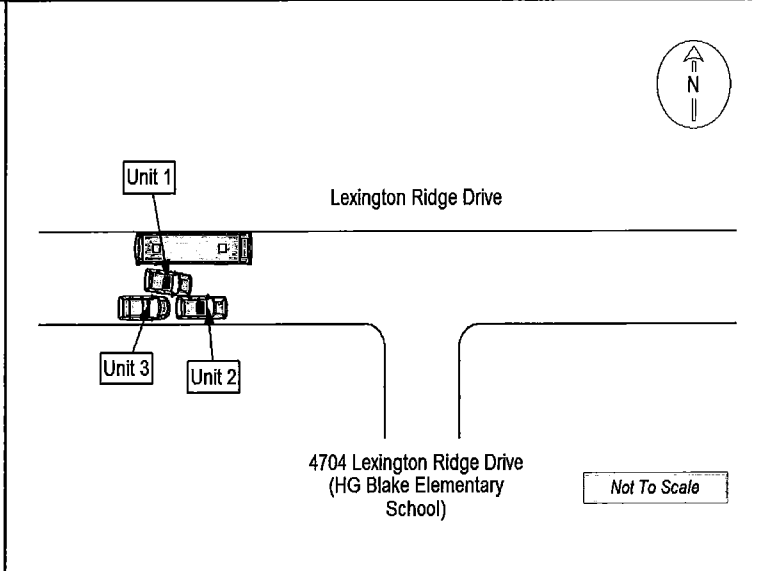

NARRATIVE

Unit 2 and 3 were facing east on Lexington Ridge Dr., waiting in line to eventually turn right in to HG Blake Elementary School. A school bus was temporarily stopped across from Unit 2 and 3, facing west. Unit 1 attempted to pass Unit 2 and 3 in between them and the bus, sideswiping both vehicles. Very minor damage was present on the driver's side front fender of Unit 3 and a dent and scratches were observed on the driver's side rear fender of Unit 2. Unit 1 showed damage on the passenger side front fender. There is dash cam video available from Unit 3. No injuries were reported and all vehicles were driven from the scene.
