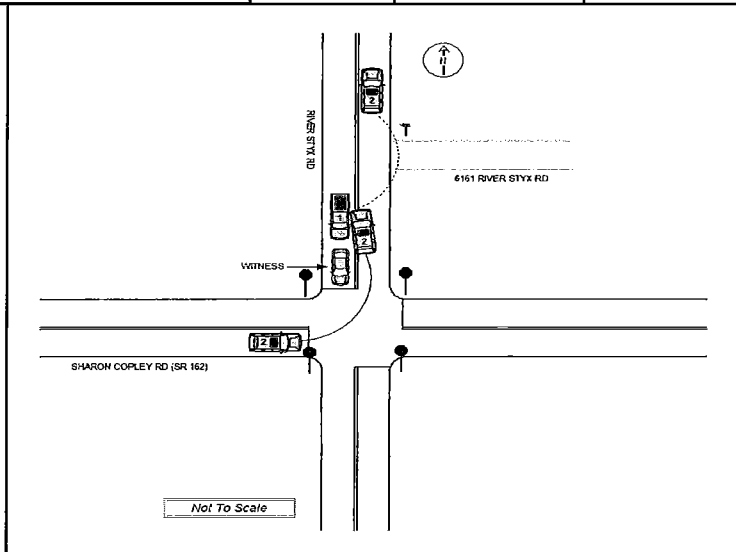

NARRATIVE

Unit #1 was southbound on River Styx Road stopped at the stop sign at Sharon Copley Road, and stopped behind another vehicle. Unit #2 was eastbound on Sharon copley turning north onto River Styx Road. Unit #2 slid on the pavement while making the turn, and sideswiped Unit #1. Unit #1 sustained non-functional damage to the driver door, rear door, running board, and rear fender. The vehicle which was stopped in front of Unit #1 witnessed the crash. Both witness and Unit #1 driver observed Unit #2 leave the scene of the crash heading northbound on River Styx Road. Both described the suspect vehicle to be a black Dodge Nitro or Jeep. Damage to the suspect vehicle would be at the driver's side front end. No injuries were reported, and Unit #1 was driven from the scene. The suspect vehicle has not been located.

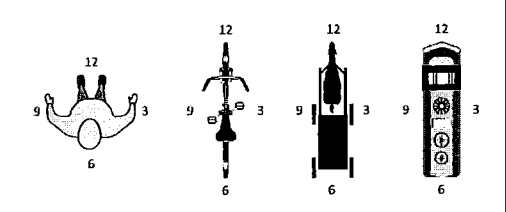
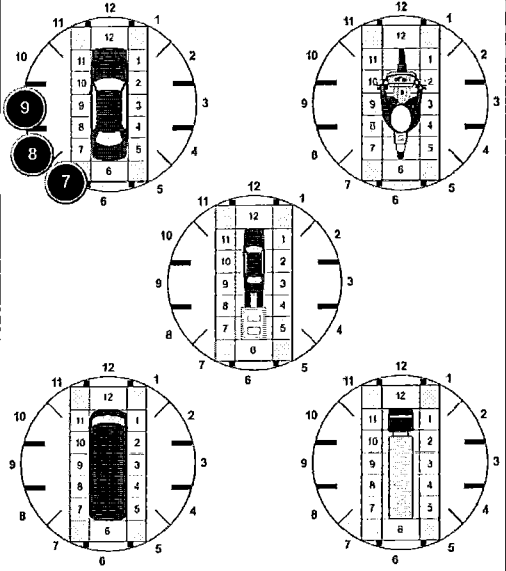
