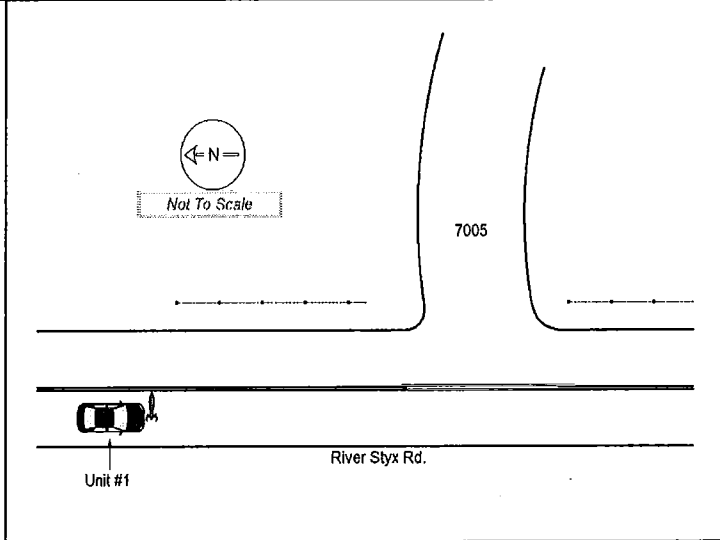

NARRATIVE

Unity #1 was southbound on River Styx Rd., just north of 7005 River Styx Rd. A deer crossed from east to west in the path of Unit #1, allowing the driver no opportunity to avoid the collision. Unit #1 sustained functional damage to the front of the car, but was driveable and required no tow. The driver claimed no injury at the scene. The deer was dispatched in the southbound, western-most ditch.
