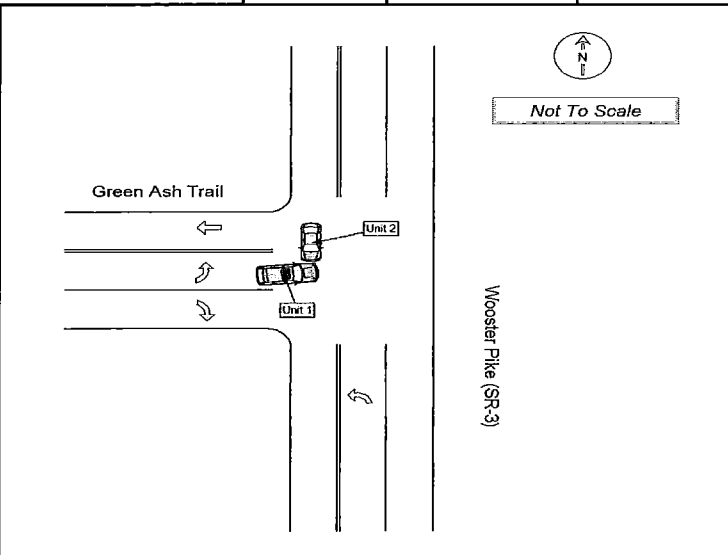

Unit 2 was traveling south on Wooster Pike (SR-3) passing Green Ash Trail. Unit 1 was attempting to make a left turn on Wooster Pike from Green Ash Trail. Unit 2 struck Unit 1 in the driver's side door and front fender. Unit 2 sustained heavy front end damage and the driver complained of neck pain. Unit 1 sustained damage to the front driver's side fender and no injuries were reported. Both vehicles were towed from the scene.
