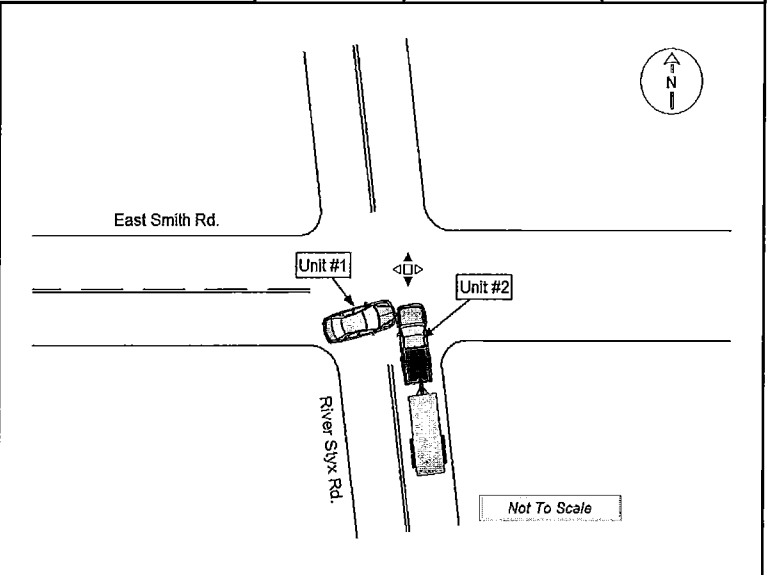

Neither driver was injured and both units were driven from the scene. The driver of Unit 2 was cited for running the red light.

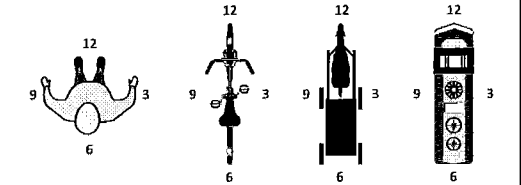
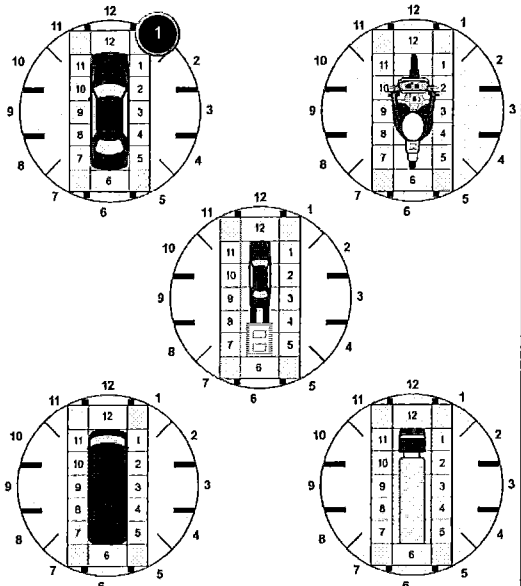

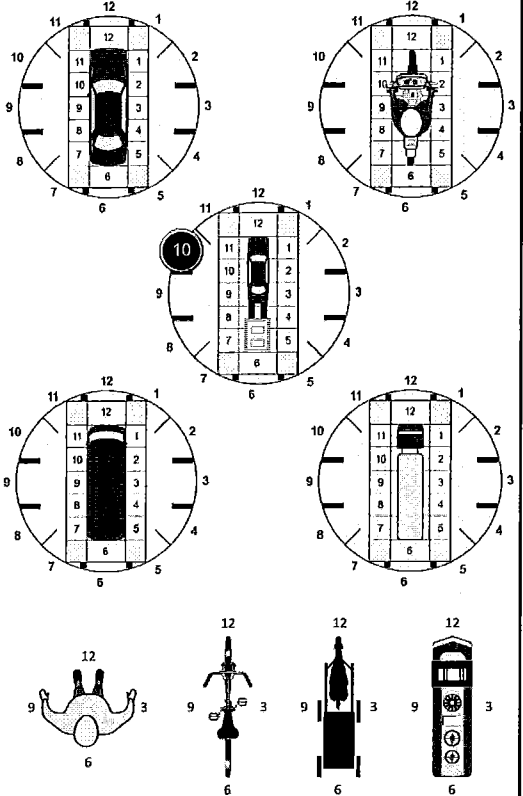
