There are several curves leading into the approach of the roundabout, starting with a curve to the right. As Unit 1 approached the beginning of the curves, Unit 2 was southbound, exiting those curves. The driver of Unit 2 stated that Unit 1 was left of center, so Unit 2 moved as far right as he could, but was unsuccessful in avoiding Unit 1. Unit 1 sideswiped Unit 2, then continued straight, missing the right-curve of the road, and struck Unit 3, which was also southbound, head on. All three vehicles suffered disabling damage, and required a tow. The driver of Unit 1 complained of arm and abdomen injuries, and the driver of Unit 3 complained of chest pain and a possibly broken thumb. The driver and passenger of Unit 2 were uninjured.

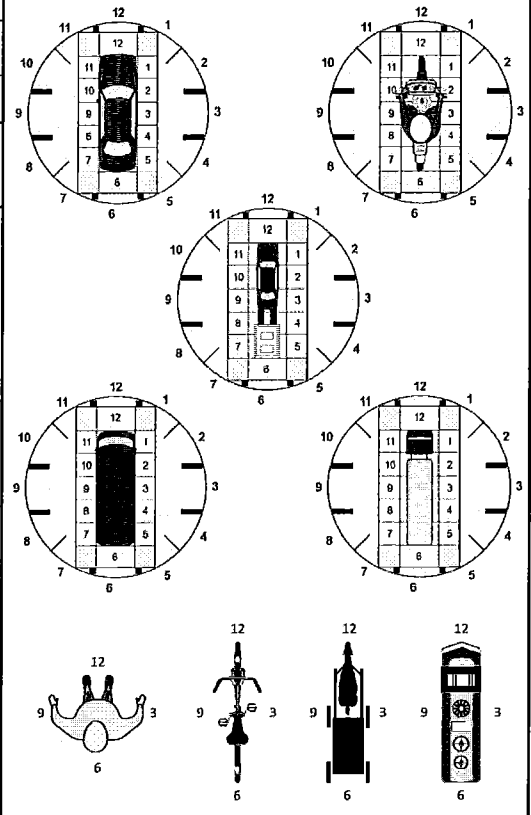

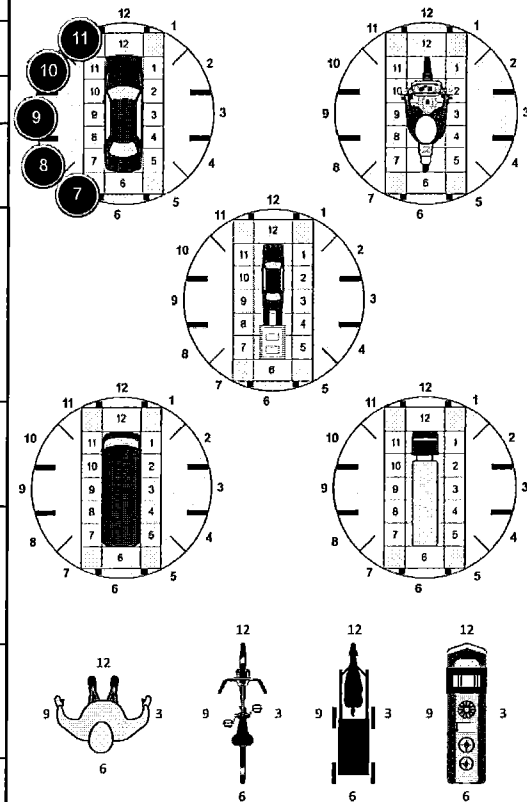
