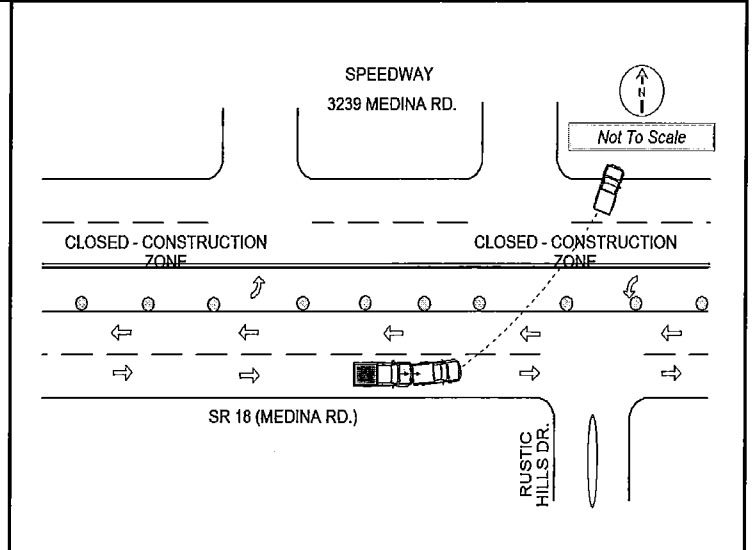

NARRATIVE
Unit #1 was eastbound on Sr 18 (Medina Rd.) and was stopped in traffic to turn north into the eastern-most access drive of Speedway. Unit #2, which was also eastbound, struck Unit #1 in the rear, causing Unit #1 to careen in a NE direction, coming to final rest in the shoulder just east of the Speedway entrance/exit. Unit #1 sustained disabling damage and was recovered by Heidi's Towing. Unit #2, which became disabled at or about the point of impact, sustained disabling damage and was recovered by Exurb Towing, which was requested by Medina Twp. Ofc. #1517. The drivers of both units were transported to Medina Hospital for treatment by Medina LST. The driver of Unit #2 was cited for ACDA. (Y42327).

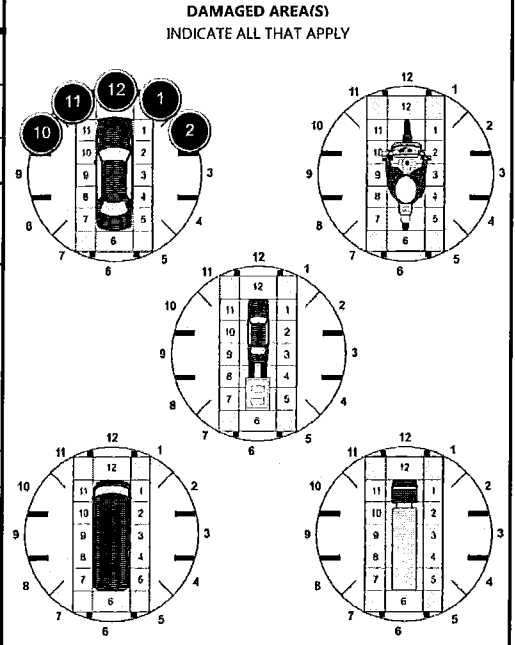
