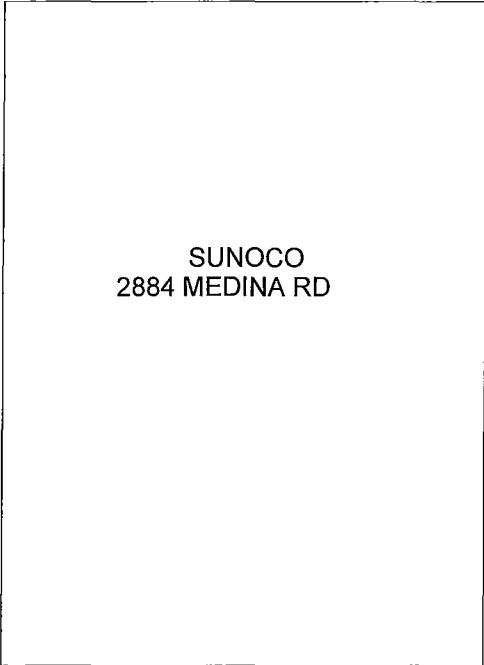
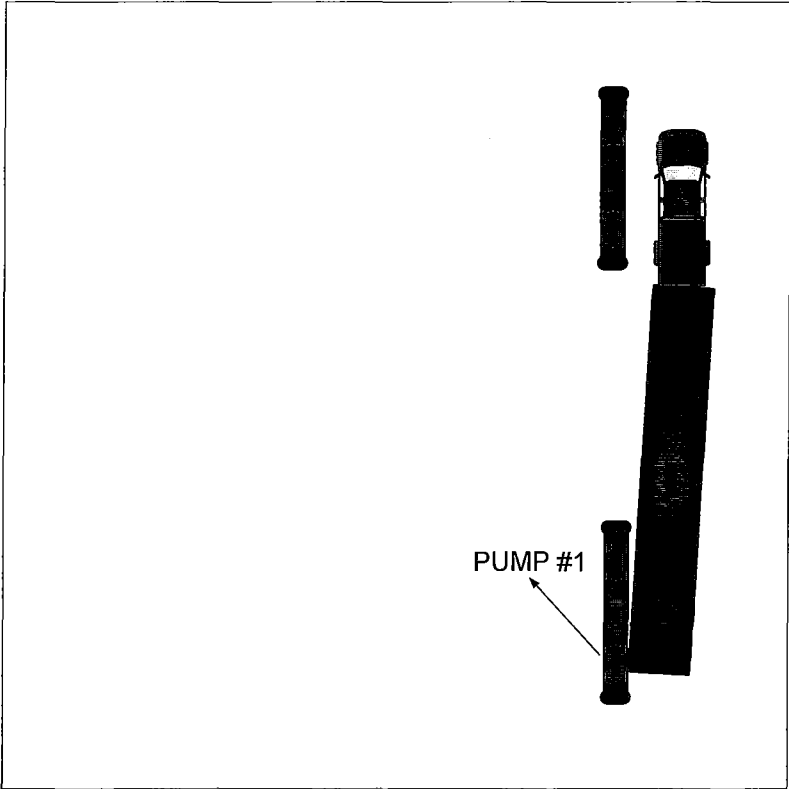

UNIT #1 THEN DROVE FROM THE SCENE TO A DIFFERENT GAS STATION FOR DIESEL. UNIT #1 WAS CONFRONTED BY THE OWNER AND STATED HE WAS SCARED AND LEFT TO TURN AROUND DOWN THE HIGHWAY TO COME BACK TO THE ORIGINAL DAMAGED GAS PUMP TO FIGURE OUT THE DAMAGES. HE WAS STOPPED AT TH 214MM AND THE ISSUE WAS RESOLVED THEN.
