NARRATIVE Unit 1, a FedEx delivery van making a delivery, pulled off to the right shoulder along Wadsworth Road while northbound. Unit 2, a semitruck with trailer, was positioned behind Unit 1 and attempted to pass. Unit 2 did not give enough space to safely pass Unit 1, and struck the driver side mirror of Unit 1, causing it to shatter and bend forward and strike Unit 1's window, also shattering that. Neither unit appeared to sustain any damage to the body, and neither driver claimed injury. Both vehicles were able to depart the scene without a tow.
