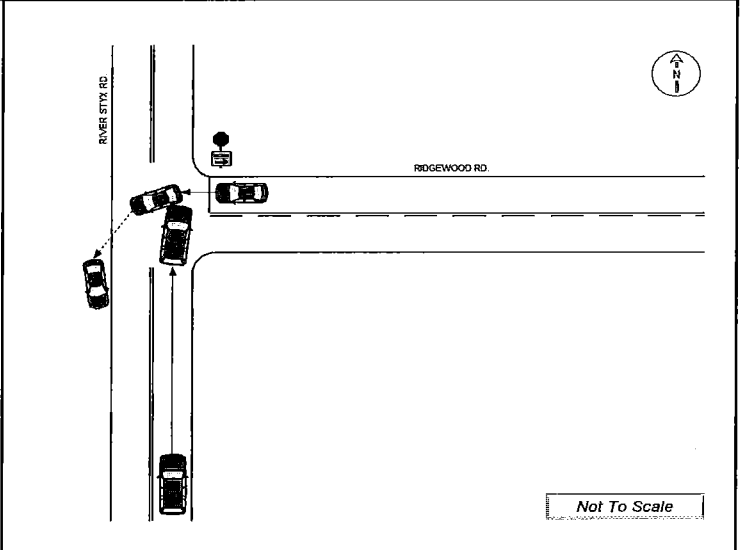

NARRATIVE

Unit #1 was northbound on River Styx Rd. approaching Ridgewood Rd. Unit #2 was westbound on Ridgewood Rd. and stopped at the stop sign for River Styx Rd. Unit #1 had its turn signal on to turn right onto Ridgewood Rd. but then turned it off to continue northbound on River Styx Rd. Unit #2 entered the intersection at this time to make a left turn after having seen Unit #1's turn signal on. Unit #1 struck Unit #2's driver's side rear wheel well area with its driver's side front bumper. Unit #2 drove into the ditch on the west side of the road on River Styx Rd. and came to final rest. Unit #2 was towed by Jon's Towing and the driver was cited with right-of-way rule at stop signs. Unit #1 was able to be driven from the scene. No injuries were reported.

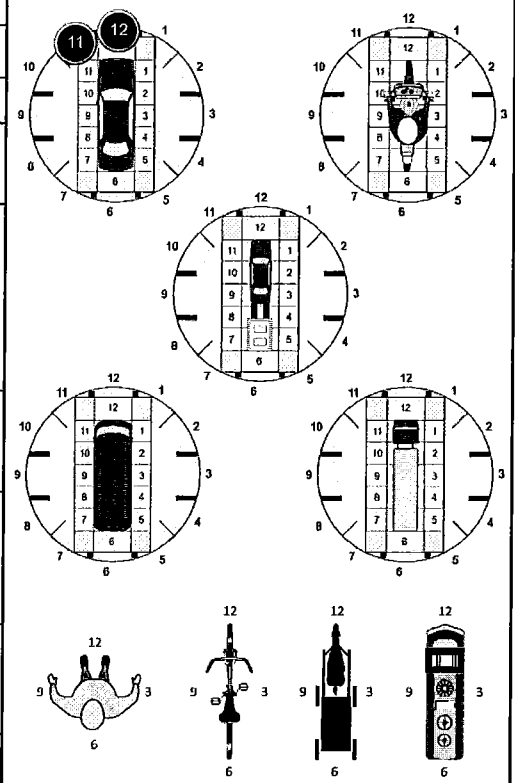

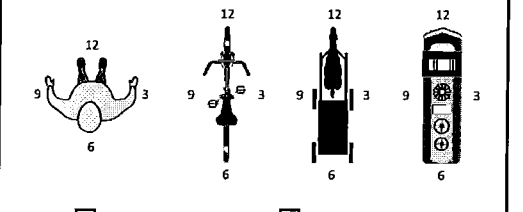
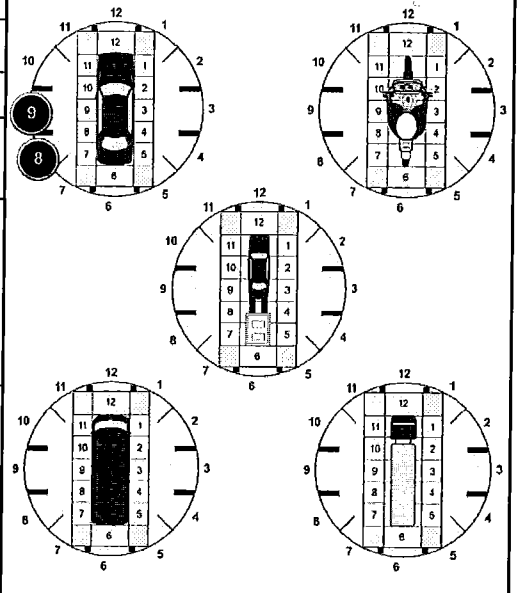
