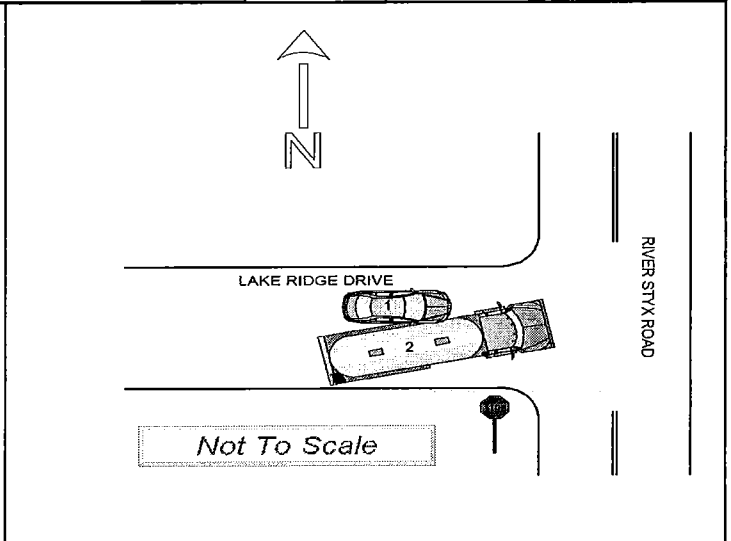

Unit #2 was stopped at the stop sign of Lake Ridge Drive and River Styx Road awaiting traffic. Unit #1 attempted to pass Unit #2 while he waited. Once traffic ceased Unit #2 began to turn left and did not know Unit #1 was attempting to pass him. Unit #2 and Unit #1 collided as Unit #2 was making his turn, causing disabling damage to Unit #1 requiring tow. No injuries were reported.
