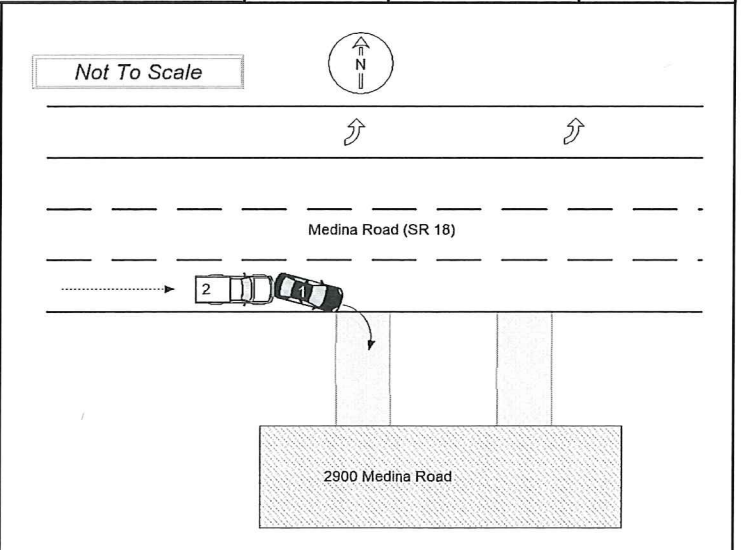

NARRATIVE  
Unit 1 was eastbound on Medina Road and slowed to turn into BP at 2900 Medina Road when Unit 2, behind Unit 1, failed to slow down and struck Unit 1's rear. Unit 1 sustained minor damage to the rear bumper. Both unites pulled into 2900 Medina Road and then Unit 2 promptly resumed eastbound on Medina Road without making contact with any of the occupants of Unit 1. The occupants of Unit 1 declined medical treatment and the vehicle was able to be driven under it's own power.
