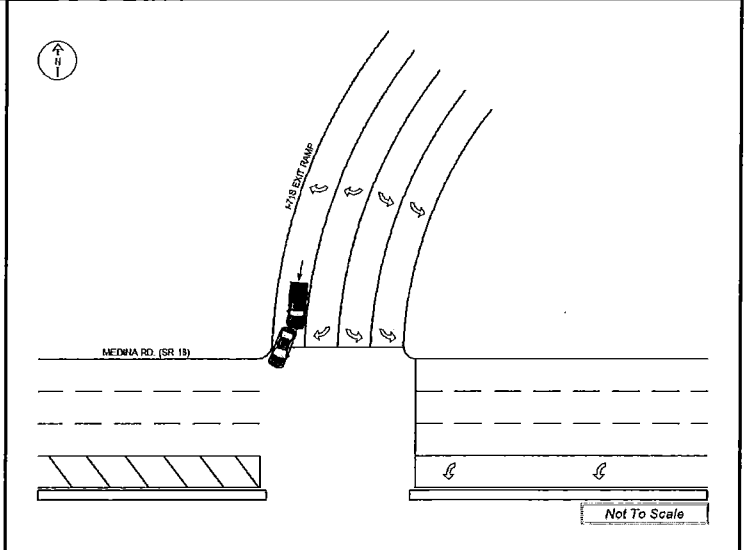

NARRATIVE

Unit #1 was exiting I-71S on the exit ramp for Medina Rd. to go westbound. Unit #2 was also on I-71S and was behind Unit #1 when both units stopped for the red light in the far right turn lane. It should be noted that Unit #2 was being test driven by a customer from Medina Auto Mall. The driver of Unit #1 advised police she was struck in the rear of her vehicle while stopped for the red light at Medina Rd. The driver of Unit #2 and his passenger advised the light went green but Unit #1 had slammed on her brakes for it. Unit #1 sustained minor damage to its rear bumper and Unit #2 sustained minor damage to its front bumper. The driver of Unit #1 was checked for injuries by Medina Life Support Team but refused transport. The driver of Unit #2 was cited for ACDA and both vehicles were able to be driven from the scene.

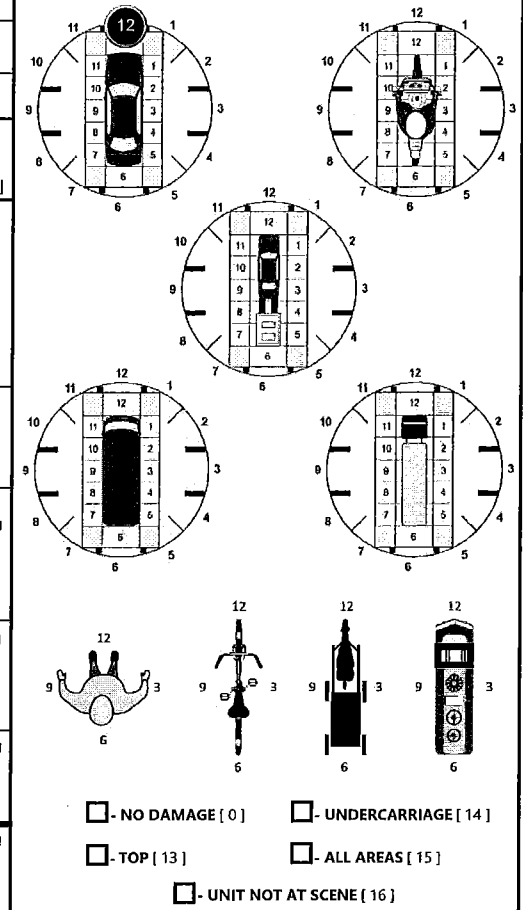
