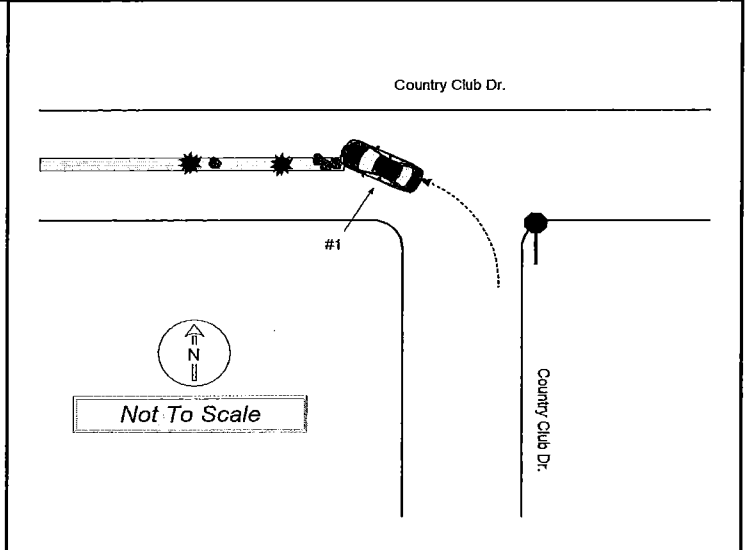

NARRATIVE
Unit #1 stopped at the stop sign at Country Club and Country Club Drive. The driver of unit #1 stated that due to increasingly hard rainfall, he adjusted his windshield wipers and in doing so, failed to negotiate a left hand turn onto Country Club Drive. Unit #1 ran over the traffic island and several landscape boulders, causing functional damage to the driver front of unit #1. Prior to arrival, unit #1 had left the scene and returned to 3199 Country Club Drive, where the report was taken. No injuries were claimed by the driver. No citation was issued.
