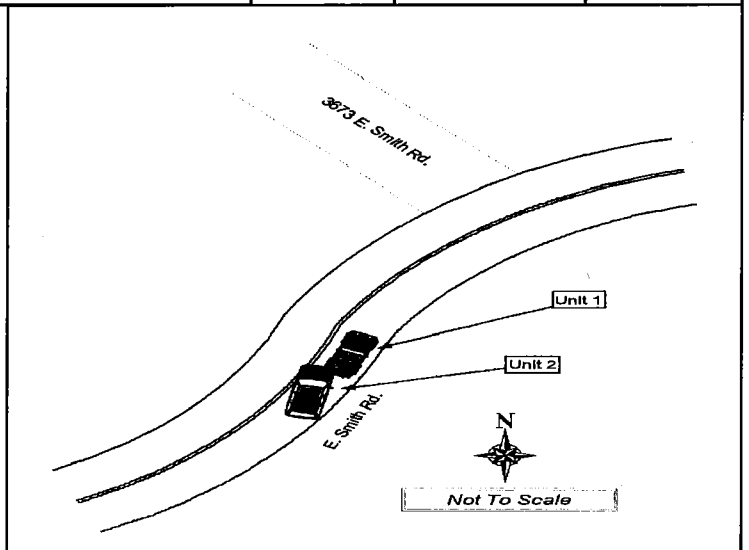

NARRATIVE
 Unit 1 was eastbound on E. Smith Road, and slowed to allow deer to cross in front. Unit 2, also eastbound on E. Smith Road, was positioned behind Unit 1 and did not realize it was slowing. Unit 2 struck the rear of Unit 1, causing functional damage to both. Although Unit 2 was drivable, the owner elected to have it towed due to the wheel well being so close to the front passenger tire. The driver of Unit 2 was cited for ACDA.

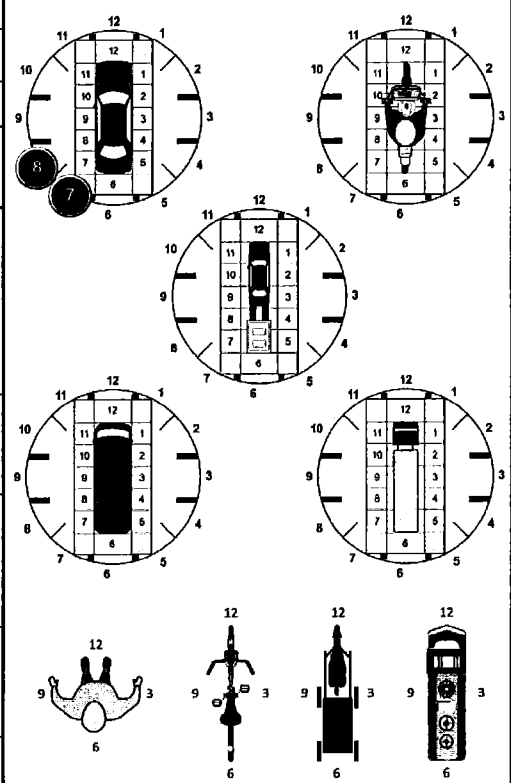
