

NARRATIVE
Unit 2 was stopped at the stop sign at the intersection of S.R. 162 and River Styx Road traveling northbound. Unit 1 was traveling northbound when Unit 1 began to brake, the driver's phone landed in at their feet, and they attempted retrieving the phone. When the driver of Unit 1 looked up after regaining his phone, the driver realized they would strike Unit 2 and attempted braking. Unit 1 then struck Unit 2 traveling at roughly 5 MPH. Unit 1 sustained functional damage to the front end but did not require a tow. Unit 2 sustained minor damage to the rear tire and rim of located on the back of Unit 2. No injuries were reported and no tow was needed. Unit 1's driver was cited with ACDA and recommended for diversion.
