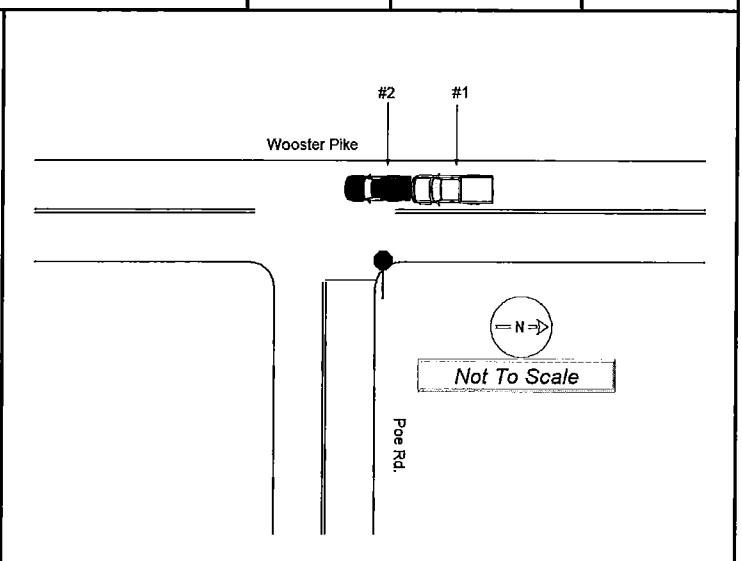

NARRATIVE
 Unit #1 was southbound on Wooster Pike. Unit #2 was also southbound on Wooster Pike and was stopped to turn left (east) onto Poe Rd. The driver of Unit #2 admitted to glancing down at his GPS, when he suddenly realized that Unit #2 was stopped to turn onto Poe. Despite hard braking, Unit #1 was unable to stop in time and struck Unit #2 in the rear, causing disabling damage to Unit #2 and functional damage to Unit #1. Unit #1 came to final rest off the right side of the roadway against a sign post. Unit #2 came to final rest approx. 75 feet south of the intersection. The female passenger of Unit #2 requested medical evaluation, but refused transport to MH. The driver of Unit #1 was cited for ACDA, and was able to drive the vehicle from the scene. A friend of Unit #2's driver loaded the disabled truck onto an equipment trailer in lieu of a commercial tow.
