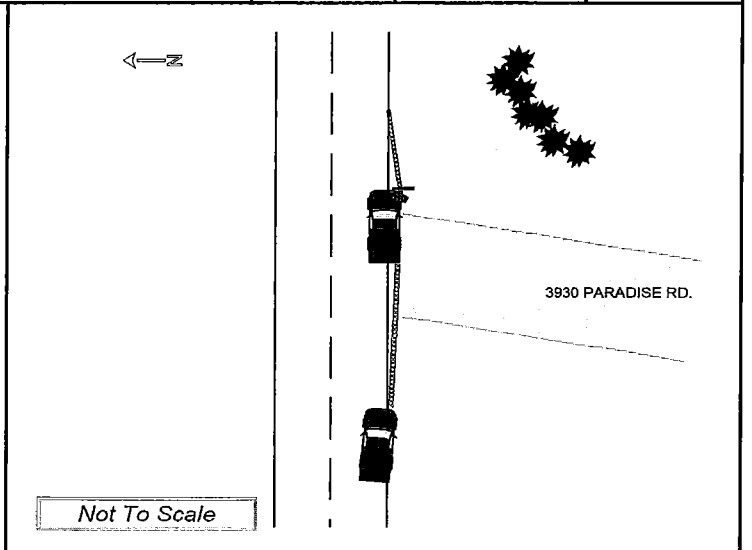

UNIT #1 WAS TRAVELING EASTBOUND ON PARADISE RD WHEN HIS VEHICLE LEFT THE ROADWAY AND WENT INTO THE BERM. UNIT #1 TRAVELLED ACROSS THE DRIVE AT 3930 PARADISE RD. AND STRUCK A MAILBOX CAUSING FUNCTIONAL DAMAGE TO THE VEHICLE. THE VEHICLE CONTINUED ABOUT A HALF A MILE DOWN THE ROAD BEFORE HE WAS FLAGGED DOWN BY THE HOMEOWNER WHOSE MAILBOX HE HIT. THEY PULLED OVER AND WAITED FOR POLICE TO ARRIVE.
