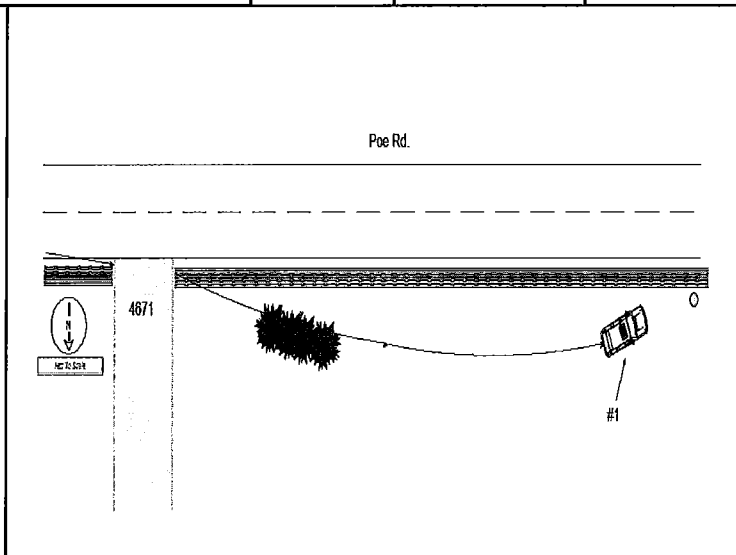

NARRATIVE
Unit #1 was westbound on Poe Rd., at or about 4671 Poe Rd., when it drove off the right side of the roadway, struck a driveway culvert end, and traversed the driveway at that address. Unit #1 then traveled through the road ditch and continued through the yard, coming to rest in the snow just east of a utility pole. The ditch and yard of 4671 Poe sustained an undetermined amount of damage. The driver of Unit #1 was cited for failure to maintain reasonable control. A tow was arranged by the driver through his insurance company. The resident at 4671 Poe was not home, but I left a business card with this report number at the side door.
