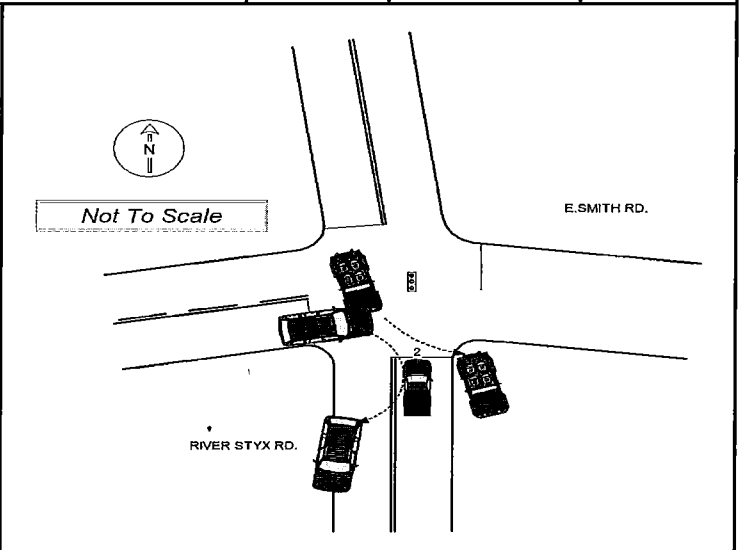

NARRATIVE  
Unit 1 was south bound on River Styx Rd. just north of E.Smith. Unit number 3 was east bound on E.Smith just west of Riverstyx Rd. As Unit # 3 entered the intersection Unit 1 failed to stop at the red light and struck Unit # 3 causing disabling damage to both vehicles. Just after impact, Unit # 3 careened into Unit 2, which was stopped facing north on River Styx Rd.
