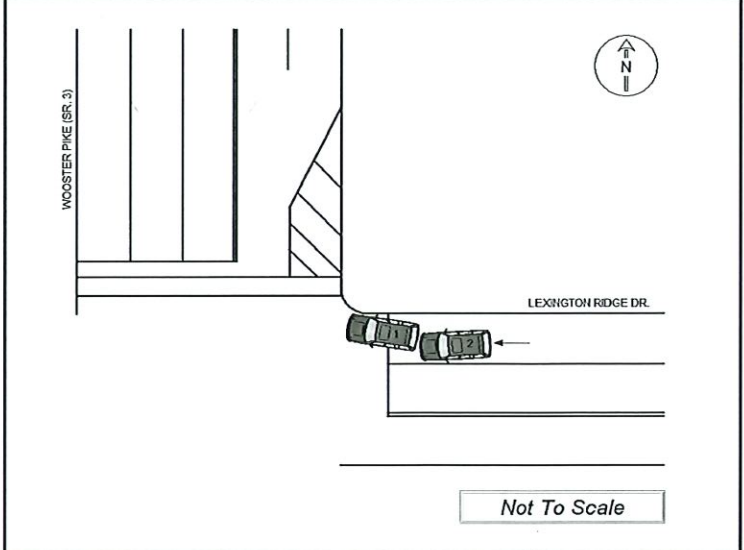

NARRATIVE
 Unit #1 was stopped at the red light on Lexington Ridge Dr. at the intersection of Wooster Pike. Unit #2 was stopped behind Unit #1 at the intersection. Unit #2 accelerated forward and struck the rear of Unit #1, believing Unit #1 was going to proceed with a right turn. Unit #1 sustained minor damage to its rear bumper and Unit #2 sustained functional damage to its front bumper. The driver of Unit #1 complained of a possible injury but declined to be checked by anyone at the scene. Both vehicles were able to be driven from the scene.
