NARRATIVE

Unit 1 was stopped in traffic while traveling northbound on River Styx Road. The driver of Unit 1 observed a vehicle waiting to pull out of the drive of 5115 River Styx Road and backed up to allow that vehicle room to enter the roadway. While Unit 1 was backing up, it failed to identify a Unit 2 behind Unit 1 and struck Unit 2. Unit 2 sustained minor damage to the front grille and Unit 1 sustained minor damage to the rear. Both vehicles were driven under their own power and both drivers denied EMS. Unit 1 was cited with starting and backing.
