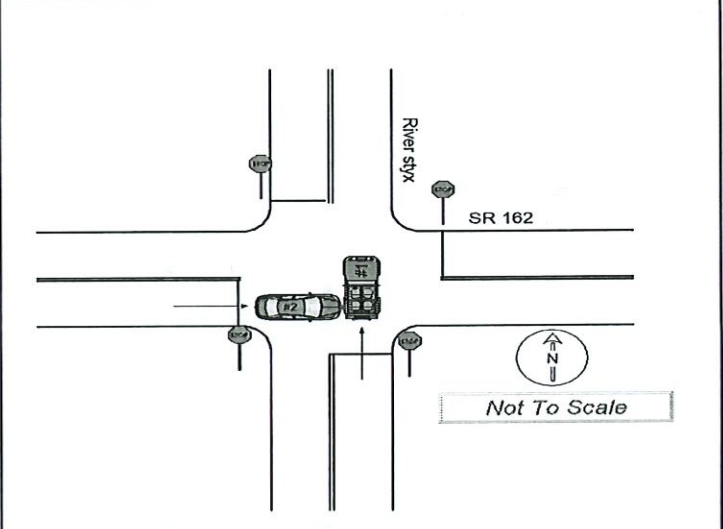

NARRATIVE

Unit #1 was traveling north on River Styx and Unit #2 was traveling east on SR 162. Drivers stated there were four cars at the four way stop including both units. Drivers going west on SR 162 and south on River Styx both went through and then unit #1 and unit #2 both went at the same time causing unit #2 to strike unit #1 on the rear driver side of the vehicle causing minor damage to unit #2 and no visible damage to unit #1. Both units stories were contradicting each other and no witnesses stayed to give a statement. Therefore, no citation was issued due to insufficient evidence. No injuries reported.
