NARRATIVE Unit #1 was stopped at the red light near the entrance to the new Frontage Rd., east of Aldi (3444 Medina Rd.). Unit #2 was also eastbound on Medina Rd. As the driver of Unit #2 attempted to change lanes from the far right to the center lane, he looked over his left shoulder and upon looking back, realized Unit #1 was stopped. He was unable to stop in time and struck Unit #1 in the rear, causing damage to both vehicles. No injuries were claimed at the scene. Neither vehicle required a tow.
