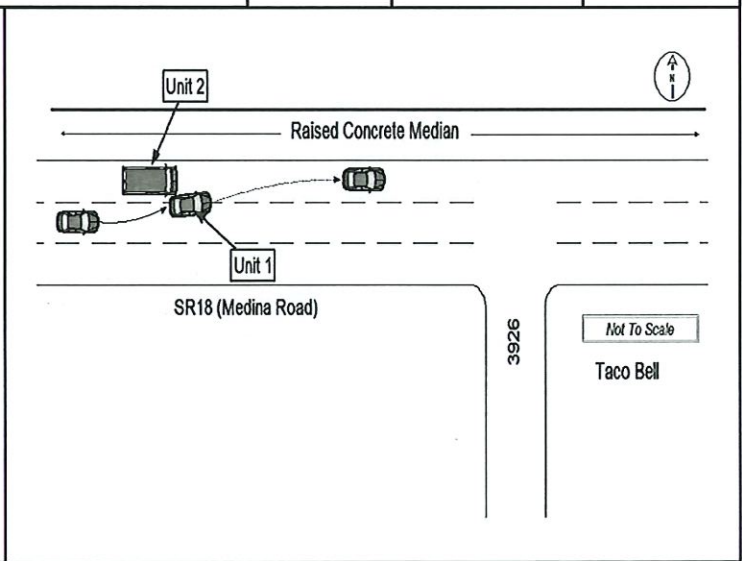

NARRATIVE
Unit 2 was traveling east on Medina Rd in the far left lane. Unit 1 was also traveling east in the middle lane. As Unit 1 passed Unit 2, Unit 1 began merging into the left lane, sideswiping the passenger front bumper of Unit 2. Both vehicles pulled onto Transportation Blvd to inspect the damage. The driver of Unit 1 denied merging into their lane, then said, "The roads are all screwed up, and the damage was not bad, so let's just let it go." She got into Unit 1 and left. Unit 2 sustained no damage. Unit 1's damage is unknown. The only information I have now is that Unit 1 is a dark grey Nissan Maxima driven by a female. I checked with McDonald's, and they have no surveillance video of Unit 1.

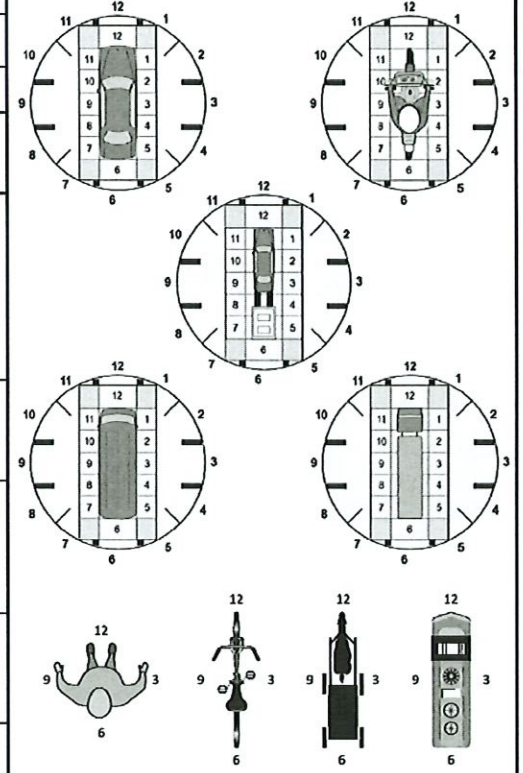
