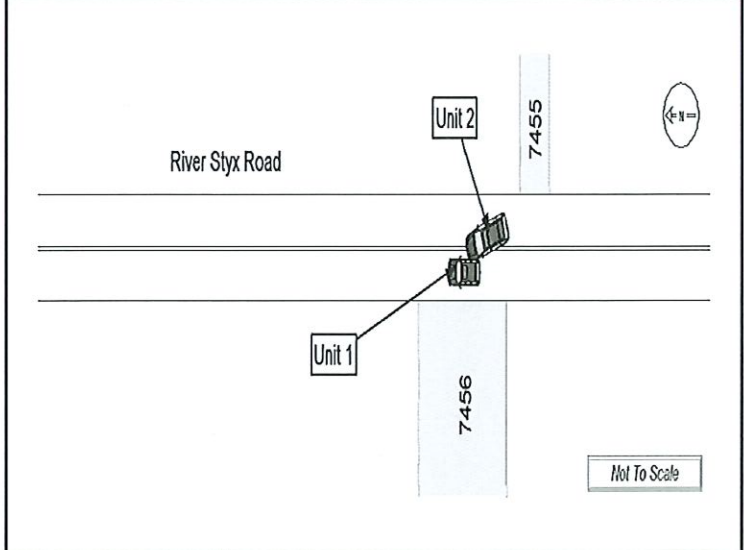

NARRATIVE

Unit 2 was traveling north on River Styx Road and attempted to make a left turn into 7456. Unit 1 also traveled north on River Styx Road and passed Unit 2 as it turned left. This section of the roadway is no-passing and is marked with a double yellow centerline. Unit 1 sustained functional damage to the passenger-side rear fender and door. Unit 2 sustained disabling damage to the front bumper and driver-side front fender. Unit 2 was towed from the scene by Exurb Towing. The driver of Unit 1 was at fault and issued a citation. No injuries were reported.

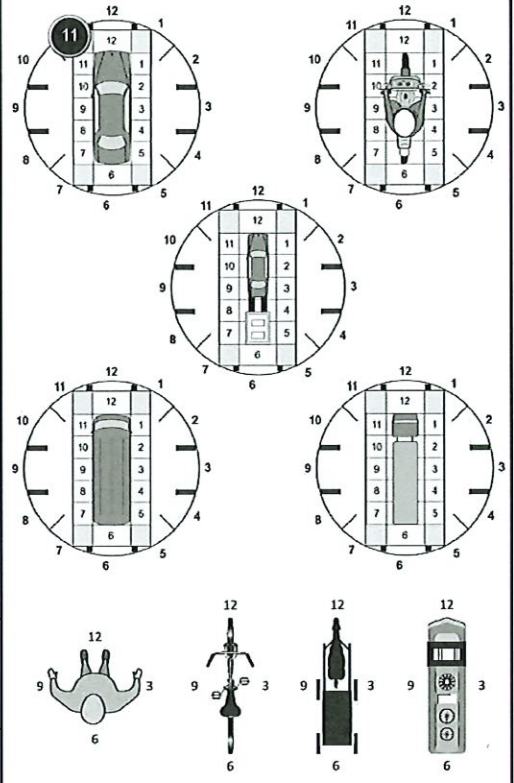
