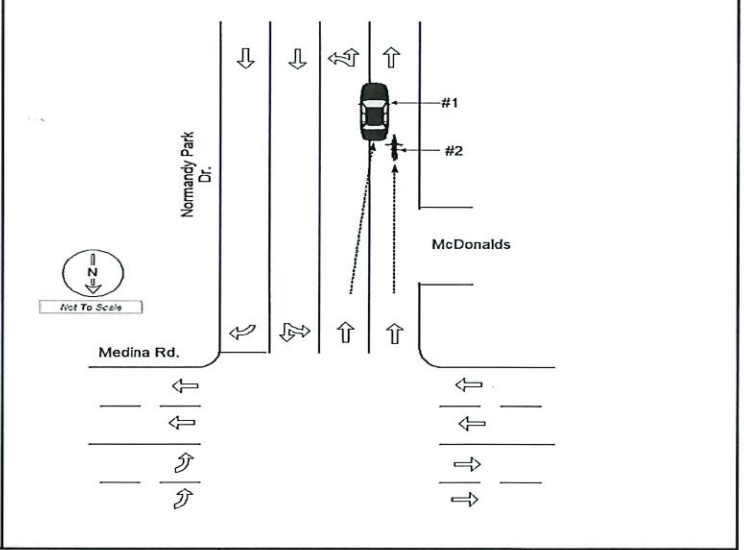

NARRATIVE

Units #1 and #2 were both westbound on Medina Road and merged into the two adjacent turn lanes which allow traffic to turn south onto Normandy Park Drive. Unit #1 was in the left lane and Unit #2, a motorcycle, was in the right lane. According to the operator of Unit #2 and an uninvolved independent witness, the driver of Unit #1 drifted to the right and outside of his lane of travel. This action caused the operator of Unit #2 to rev the motorcycle's engine in an attempt to alert Unit #1's driver. The operator of Unit #2 was forced to brake aggressively, causing Unit #2 to lose control and crash within its lane of travel. The driver of Unit #1 stated he was fully within his lane and heard a loud revving sound, causing him to become startled. He then stated that he saw a motorcycle on the ground in his rear view mirror. Based on the location of the motorcycle's final rest, the scratch marks on the roadway, and the verbal account of the independent witness, a citation was issued to the driver of Unit #1 for marked lanes. The operator of Unit #2 was ejected off of the motorcycle and sustained injuries that included several broken bones. He was transported from the scene to Medina ED by LST Medic 4. Unit #1 has a slight red paint transfer consistent with a sideswipe, but both parties denied contact between the units. Unit #2 was towed by Bear's Towing.

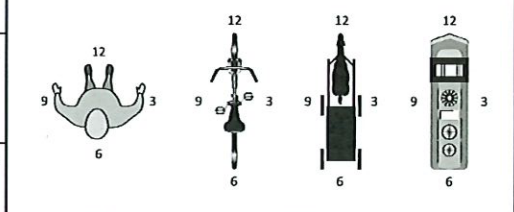
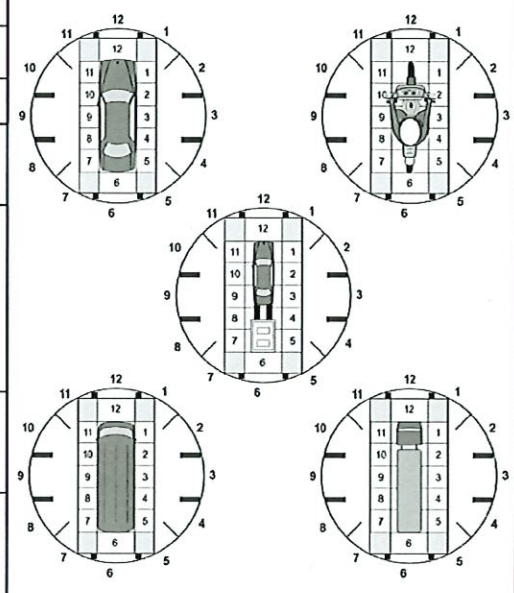
