### 23-21289

Unit #1 was backing from a parking space. Unit #2 was also in the process of backing from an adjacent parking space. Units #1 and #2 collided at a very slow reverse speed, causing minor damage to both vehicles. No known or apparent injuries were claimed at the scene, however the driver of Unit #2, who has suffered from chronic pain for 12 years, wondered if he should be medically evaluated, but declined LST and opted to possibly go to Medina Hospital on his own.
