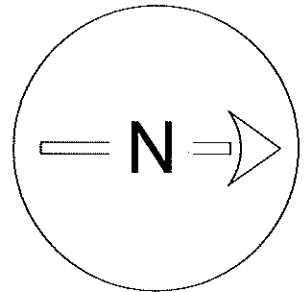
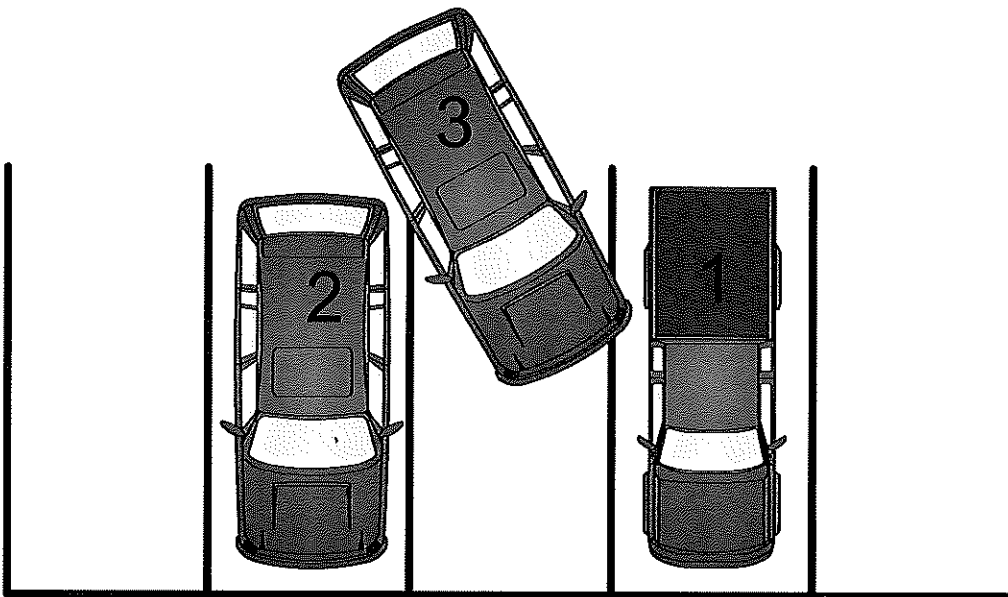

Narrative: Unit #1 was parked and occupied in a marked parking space in the parking lot of 2736 Medina Road. Unit #2 was parked and unoccupied in a marked parking space in the same lot, 2 spaces to the south of Unit #1. Unit #3 attempted to enter the empty parking space between Unit #1 and Unit #2. While entering the space, Unit #3 struck Unit #1, causing minor damage to the rear passenger door of Unit #1 and minor damage to the front driver side bumper of Unit #3. Unit #3 then reversed and struck Unit #2, causing damage to the driver rear quarter panel and bumper cover of Unit #2, and damage to the passenger front bumper of Unit #3. The driver of Unit #3 then left the scene without contacting either driver or leaving any contact information. Through investigation the driver of Unit #3 was located, identified, and cited for leaving the scene.
