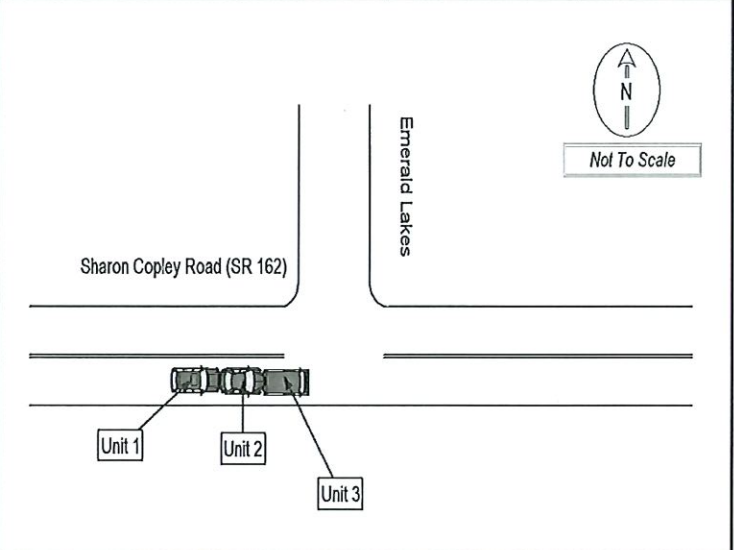

The driver of Unit 1 advised she looked left and when she looked up she could not stop in time, striking the back of Unit 2. This caused Unit 2 to strike the back of Unit 3. All injured were treated on scene and not transported. Unit 2 was towed by TransCounty and Unit 1 was towed by Lloyds Towing.
