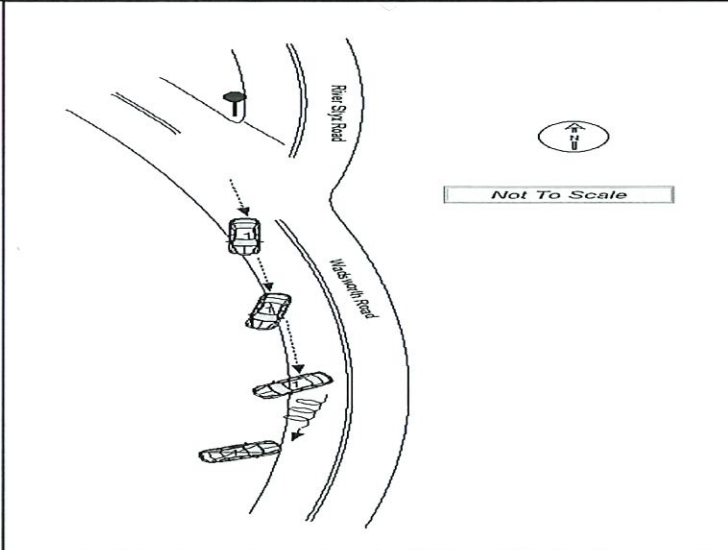

NARRATIVE  
 Unit 1 was traveling southbound on Wadsworth Road when it went off roadway to the right. Unit 1's front end struck the ditch, causing it to spin around and flip over, which resulted in Unit 1's trunk striking the ditch. The vehicle came to rest turned over with side air bags deployed. The driver stated that he was traveling 45 MPH and was transported to Medina Hospital by Medina LST. Unit 1 was towed by Jon's Towing. The driver was suspected of OVI and submitted to a urine test. The urine results returned from the Ohio State Highway Patrol Crime lab with a result of 0.153 g/100ml. The driver was cited for OVI and Failure to Control on 2/13/23.
