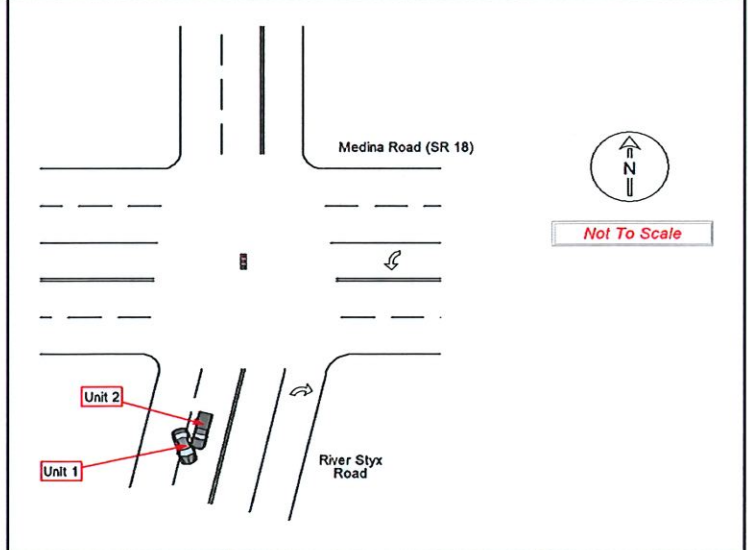

**NARRATIVE**  
Unit 1 and Unit 2 both turned on to River Styx Road from Medina Road (SR 18.) Unit 2 was behind Unit 1. Unit 1 turned into the curb lane and Unit 2 turned into the center lane. Unit 1 attempted to change lanes to the center lane striking Unit 1 in the front right bumper and was also struck in the driver's side door. No injuries were reported. Unit 2 was driven from the scene and Unit 1 was moved to a parking lot to be later evaluated.

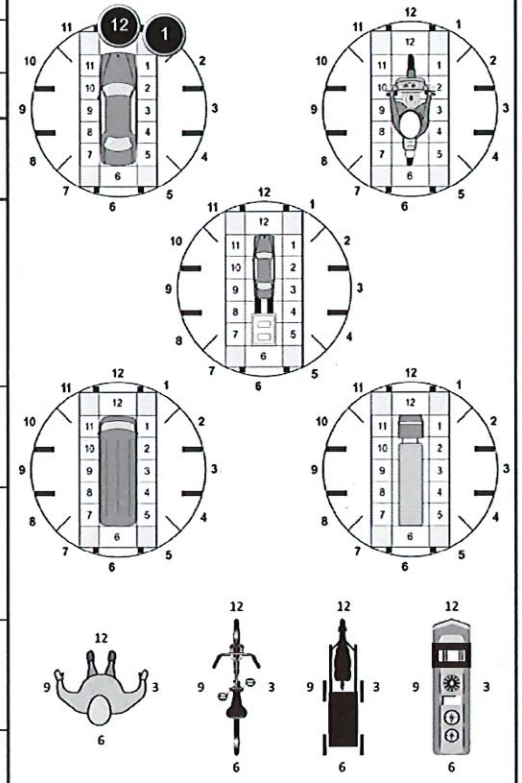
