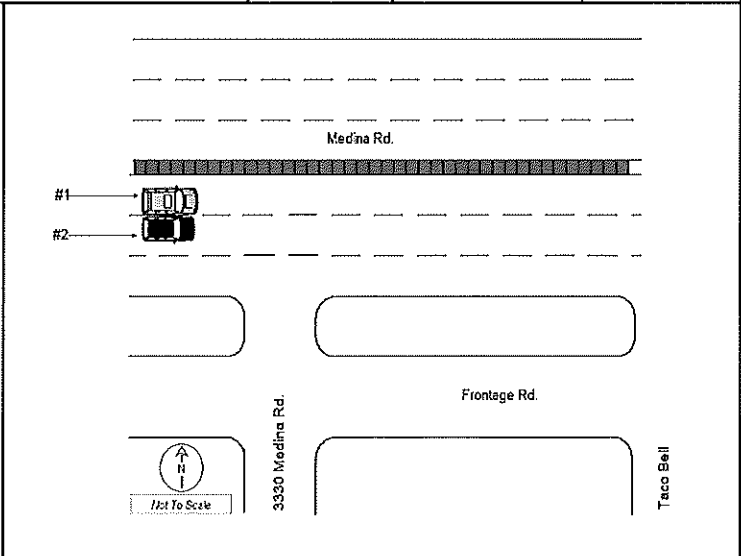

NARRATIVE
Units #1 and #2 were both eastbound on Medina Rd., between Aldi and Kinder Care when they were involved in a sideswipe collision. The passenger side of Unit #1 made contact with the driver side of Unit #2, causing minor damage to both vehicles. Through investigation, it was undeterminable who, if either, left their lane of travel. Both drivers contended that they maintained their lane. There are no ODOT cameras in the area to prove or disprove their statements. At this time, there are no known independent witnesses. No injuries were claimed at the scene. No recovery was required for either vehicle. No citation was issued to either party for the lack of evidence present to find fault with either driver.

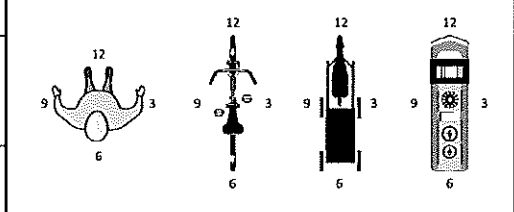
