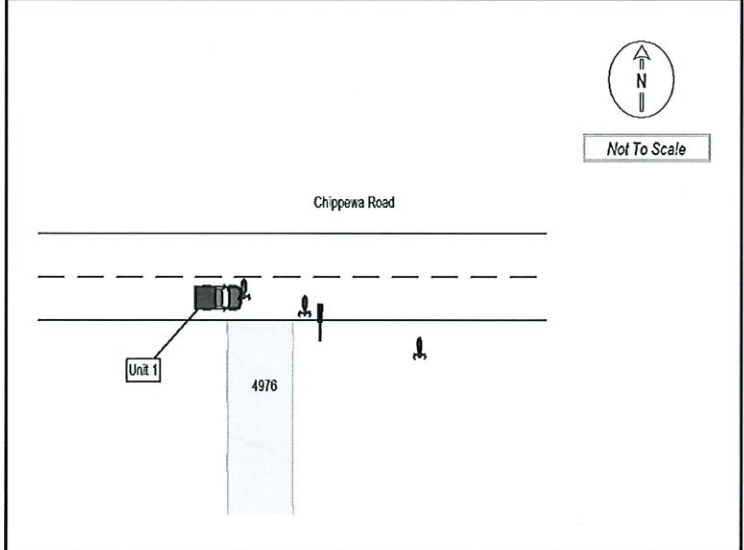

Unit 1 was traveling east on Chippewa Road in the 4300 block. A deer began to cross in front of Unit 1, causing Unit 1 to strike the deer. The deer then was propelled into the mailbox at 4976 Chippewa Road causing it to be damaged. The dead deer was in brush on the south side of the road. Unit 1 sustained damage to the passenger side front end. Unit 1 was driven from the scene. The resident at 4976 Chippewa was advised about the damage to their mailbox.

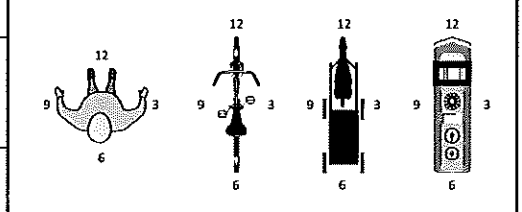
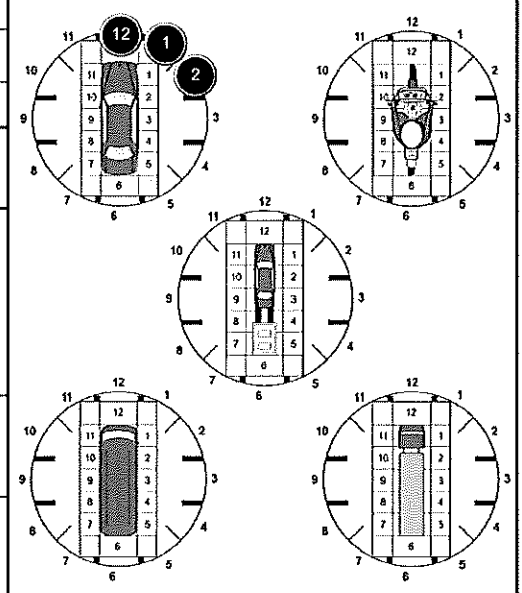
