Unit 1 was facing south on a private access road which connects GetGo, Chipotle and Starbucks. Unit 2 was overtaking a parked semi occupied by driver, Dave Tatro [REDACTED]. The driver of Unit 1 advised he was stationary and Unit 2's trailer scraped the driver's side rear quarter panel. The driver of Unit 2 advised Unit 1 began to move and was both struck and striking as he turned. Tatro advised Unit 1 originally stopped, backed and eventually moved forward initiating contact.
