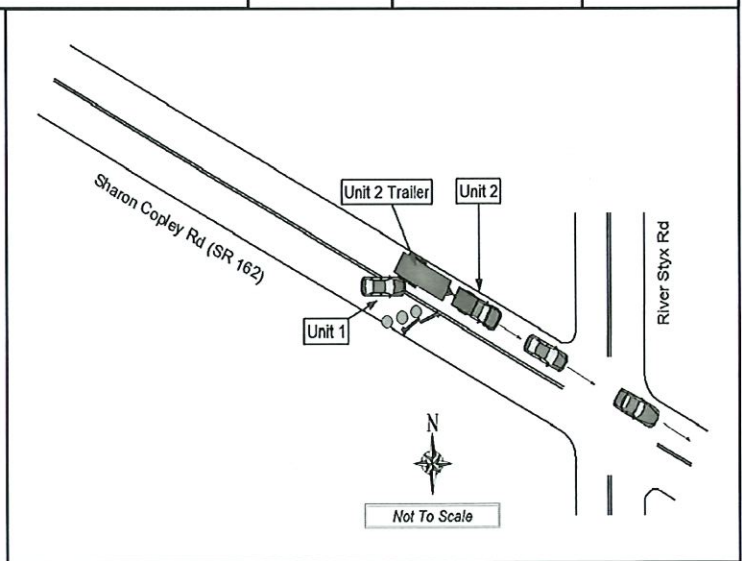

NARRATIVE

Unit 1 was eastbound in the eastbound lane of Sharon Copley Rd, which was closed for construction. He came to the final blockade near the intersection of River Styx, where construction equipment was blocking his way. Traffic flaggers had eastbound traffic flowing freely in the westbound lane, which was actively flowing to the left side of Unit 1. Unit 1 attempted to change lanes into the eastern flowing traffic, and entered into the path of Unit 2, a landscape truck and trailer. The passenger side of the trailer of Unit 2 sideswiped the driver's side of Unit 1, causing functional damage. It flattened the left rear tire, which was replaced with a spare prior to being towed. Unit 1 appeared to still be functional, but the owner elected to have it towed anyway. No injuries were reported, and the driver of Unit 1 was cited for turn and stop signals, for failing to ensure safety prior to changing lanes.

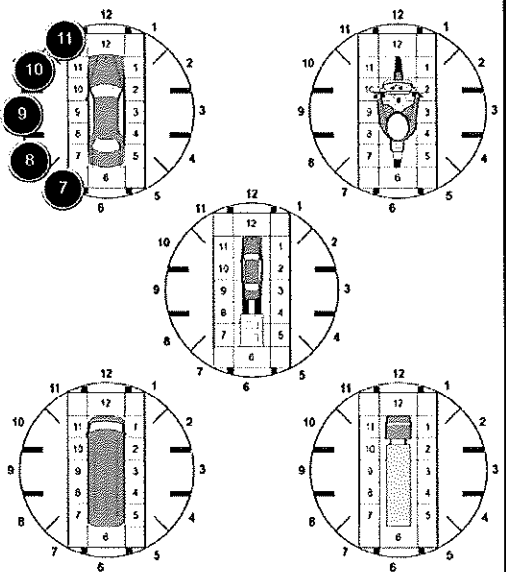

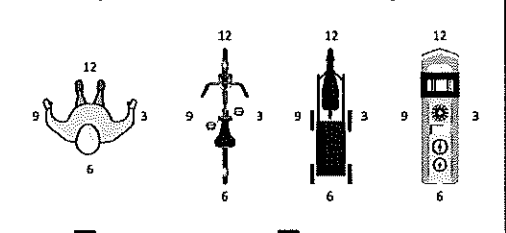

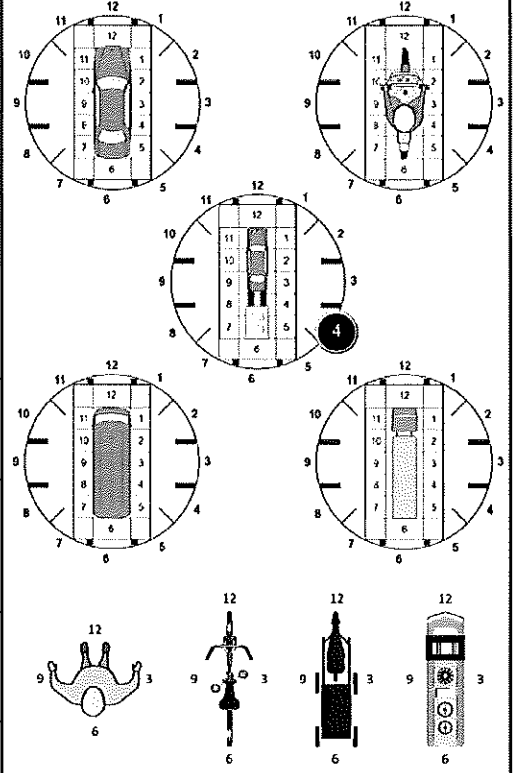
