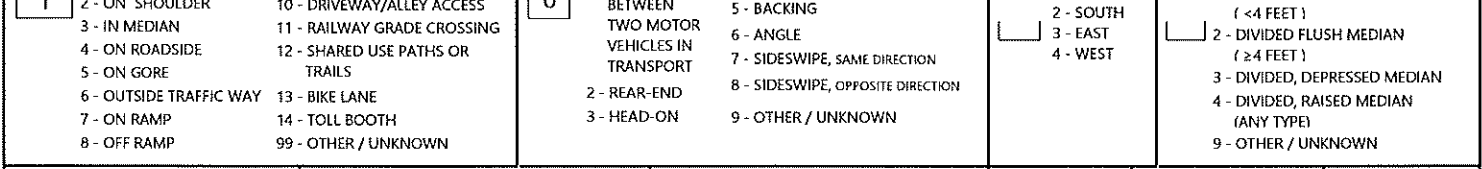

Unit 1 was making a right turn onto Lexington Ridge from Wooster Pike. Unit 2 was stopped in the left turn lane on Lexington Ridge to turn south on Wooster Pike. While making the right turn, Unit 1 slid into the driver-side front bumper of Unit 2. Unit 1 had minor scratches on the driver-side front bumper. Unit 2 sustained functional damage to the driver-side front bumper. No injuries were reported, and both vehicle were driven from the scene. The driver of Unit 1 was issued a citation for reasonable control.

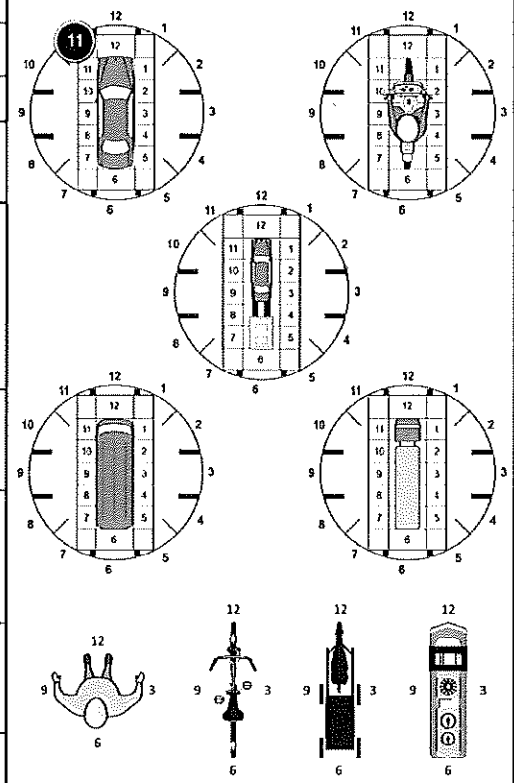
